**SUBJECT:** Resolution and Order to Establish  
the Deadline to File Requests for Clarification.

**RESOLUTION AND ORDER**

After an extensive and thorough process, which included ample opportunity for stakeholders and the general public to participate, on May 21, 2021, the Energy Bureau of the Puerto Rico Public Service Regulatory Board (“Energy Bureau”) issued a Resolution and Order (“May 21 Order”) to establish baselines and benchmarks for certain performance metrics.<sup>1</sup>

These foregoing baselines and benchmarks will, among other things, be the basis to determine the targets for the performance metrics which will apply to LUMA ENERGY, LLC as Management Co., and LUMA ENERGY SERVCO, LLC as ServCo. (collectively, “LUMA”), in the ongoing proceeding under Case No. NEPR-AP-2020-0025.<sup>2</sup>

On June 3, 2021, LUMA filed a motion titled *Request to Re-Schedule Proceedings* (“Request”). The Request was filed under Case No. NEPR-AP-2020-0025.<sup>3</sup> Through this Resolution and Order, the Energy Bureau takes administrative knowledge of the Request, therefore including it in the instant docket. In the Request, LUMA expressed that it will file a request for clarifications and/or partial reconsideration of the May 21 Order. For that reason, LUMA requested the Energy Bureau to modify the procedural calendar established on April 8, 2021<sup>4</sup> in Case No. NEPR-AP-2020-0025.

The instant case is not an adjudicative proceeding. Therefore, a request for reconsideration is not applicable to the May 21 Order. Notwithstanding, the Energy Bureau

has determined that, given the impact the May 21 Order has in Case No. NEPR-AP-2020-0025, it will entertain and consider LUMA's forthcoming filing.


As such, the Energy Bureau **GRANTS** LUMA until **June 11, 2021**, to file its request for clarifications and/or partial reconsideration. Stakeholders and interested parties **may** file their comments to LUMA's filing **on or before June 21, 2021**.
