RELIEF AND DESIGNATION OF EXAMINING OFFICER

On April 7, 2021, Counsel José A. Sadurní Lahens was appointed by the Puerto Rico Energy Bureau, as the Examining Officer in this case. This designation has been cancelled effective today, June 15, 2021.

On July 3, 2018, the Puerto Rico Energy Bureau ("Bureau") issued a Resolution authorizing Counsel Dennis Seilhamer Anadon to serve as Hearing Examiner in the Formal Bill Review Proceedings pursuant the provisions of Regulation 8863¹ and in the Claims proceedings pursuant the provisions of Regulation 8543².

Counsel Seilhamer Anadon has been appointed by the Bureau as an Examiner to conduct the proceedings of the above captioned case. Attorney Seilhamer shall have the authority to (1) administer oaths and take depositions; (2) issuing subpoenas; (3) receive and evaluate evidence; (4) preside hearings; and (5) hold conferences to streamline procedures. This does not include the imposition of administrative fines.

The appointment of Counsel Seilhamer Anadon will remain in force until the Bureau expresses the contrary.
