INORMATIVE MOTION AND RESERVATION OF RIGHTS

TO THE PUERTO RICO ENERGY BUREAU:

COME NOW, LUMA ENERGY, LLC as Management Co., and LUMA ENERGY SERVCO, LLC (collectively, LUMA), through the undersigned legal counsel and respectfully state and request the following:

- 1. On June 29, 2021, LUMA requested reconsideration of the Resolution and Order issued on June 15, 2021, whereby this Puerto Rico Energy Bureau ("Energy Bureau") denied LUMA's request filed on June 11, 2021, entitled "Urgent Request for Brief Extension of Time until June 16, 2021, To File Motion for Clarifications and/or Partial Reconsideration of Resolution and Order of May 21, 2021," and imposed a fine of \$500.00 per day starting on June 12, 2021, for every day or part thereof, until LUMA filed a submission authorized by the Energy Bureau in this proceeding ("LUMA's Motion for Reconsideration of Imposition of Fine").
- 2. At 6:11 pm of Friday, July 2, 2021, LUMA received a Resolution and Order issued by this honorable Energy Bureau whereby, among others, the Energy Bureau directed LUMA to pay a fine of \$2,500.00 only one business day later, on or before July 6, 2021 at 5:00 p.m., ("July

- 2nd Resolution and Order"). The Energy Bureau also warned LUMA that additional fines could be imposed. *See* July 2nd Resolution and Order at page 10.
- 3. In the July 2nd Resolution and Order, the Energy Bureau took notice of LUMA's Motion for Reconsideration of Imposition of Fine but did not expressly address the arguments raised by LUMA in such Motion. *See* July 2nd Resolution and Order at pages 3 and 10.
- 4. In the July 2nd Resolution and Order, the Energy Bureau did not apprise of the procedural due process rights attaching to a determination of imposition of a fine to LUMA. *See id.*
- 5. LUMA respectfully understands that the Motion for Reconsideration of Imposition of Fine is still pending final adjudication by the Energy Bureau.
- 6. It is respectfully submitted that to avoid imposition of additional fines and given the short-time frame afforded to pay the fine of less than one business day, LUMA has paid today the fine of \$2,500 as assessed in the July 2nd Resolution and Order, by electronic payment. A screenshot of the confirmation of this payment is included in the attached Exhibit 1. LUMA reserves any and all rights to request additional remedies in connection with the imposition of the \$2,500.00 fine, including requesting relief from the Energy Bureau and/or judicial review.

WHEREFORE, LUMA respectfully requests this Honorable Bureau **take notice** of the aforementioned.
