SUBJECT: Order to Show Cause

ORDER

On April 5, 2021, PBJL Energy Corporation filed a Complaint before the Puerto Rico Energy Bureau ("Energy Bureau") against the Puerto Rico Electric Power Authority (PREPA), regarding the Request for Proposal ("RFP") No. 112648 issued by PREPA for Renewable Energy Generation and Storage Resources. That same day, the Energy Bureau issued the Summons in compliance with Section 3.03 of Regulation 8543.¹

Regarding the notice of claims giving rise to an adjudicative action or proceeding before the Energy Bureau, Section 3.05(A)(1) of Regulation 8543 states that when a respondent is a certified electric service company, notice shall be served according to the following standards: "[o]n or before the period of fifteen (15) days after having filed the claim giving rise to the adjudicative action or proceeding before the Energy Bureau, the summons issued by the Energy Bureau shall be sent to the petitioned company via certified mail, along with a true and exact copy of the filed claim, including all annexes if any". Furthermore, Section 3.05(A)(4) requires that "[o]n or before the period of ten (10) days of having notified the petitioned electric service company of the claim initiated against them, the petitioner shall inform the Energy Bureau of this through motion. Pursuant to Section 12.01 of Regulation 8543 the Energy Bureau may issue any order or resolution it deems necessary to enforce rules, regulations, orders, and decisions, including the dismissal of a case or proceeding.

The periods stated above have expired. The petitioner has not informed the Energy Bureau of having notified the respondent of the present claim.
