SUBJECT: Motion Requesting a Brief Extension for LUMA to Answer ICPO's First Requirement of Information.

RESOLUTION

On October 8, 2021, LUMA¹ filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion Requesting a Brief Extension for LUMA to Answer ICPO's First Requirement of Information* ("LUMA's Motion"). Through its Motion, LUMA states that on September 30, 2021, the Independent Consumer Protection Office ("ICPO") served its *First Requirement of Information* on LUMA ("ICPO's ROI 1"). LUMA states that based on the Energy Bureau's August 31, 2021 Resolution and Order,² the deadline to respond to ICPO's ROI 1 is October 12, 2021.

Through its Motion, LUMA argues that the matter covered by ICPO's ROI 1 is technical and requires review and consideration by at least three witnesses that have submitted prefiled testimony in the instant case.³ Further, LUMA states that LUMA staff involved in the preparation of these responses is simultaneously engaged in operating the Transmission and Distribution System and involved in other proceedings before the Energy Bureau.⁴ LUMA states that based on the current calendar, it afforded only six business days to prepare its answer to ICPO's ROI 1, placing LUMA in an unfair position detrimental to its interests in this proceeding.⁵ Therefore, LUMA requested to extend the deadline to respond to ICPO's ROI 1 until October 14, 2021, at 5:00 p.m.

The Energy Bureau **GRANTS** until **October 14, 2021, at 5:00 p.m.**, for LUMA to respond to ICPO's ROI 1.
