SUBJECT: Urgent Request to Reschedule Technical Conference.

RESOLUTION AND ORDER

On October 15, 2021, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order whereby it ordered LUMA¹ and the Puerto Rico Electric Power Authority ("PREPA") to appear at a Technical Conference set for October 20, 2021 at 10:00 a.m. The purpose of the Technical Conference was, among others, different aspects of the September 20 Filing² and answer questions from the Energy Bureau.

On October 18, 2021, LUMA filed a document titled *Urgent Request to Re-Schedule Technical Conference of October 20, 2021* ("Request"). LUMA states that the timeframe allotted for the preparation for the Technical Conference is insufficient and does not allow LUMA to responsibly prepare to address the topics of the agenda.³ LUMA states that it needs additional time to prepare on the subject matters that call for comparative discussions of its operations compared to PREPA's operations, regarding SAIDI and SAIFI.⁴ Also, LUMA informs that two of its witnesses, involved in the preparation and review of the September 20 Filing, are not available for the October 20, 2021 Technical Conference due to previously scheduled professional commitments.⁵ Therefore, LUMA requests for the Energy Bureau to reschedule the October 20, 2021 Technical Conference.

Upon review of the Request, the Energy Bureau **RESCHEDULES** the Technical Conference for **November 4, 2021 at 10:00 a.m.**
