**SUBJECT: Informative Motion on Interconnection
Capacity Maps.**

INFORMATIVE MOTION ON INTERCONNECTION CAPACITY MAPS

TO THE PUERTO RICO ENERGY BUREAU:

COMES NOW, LUMA ENERGY SERVCO, LLC (LUMA), through the undersigned legal counsel and respectfully state and request the following:

1. In a Resolution and Order of December 31, 2020 (“December 31st Resolution and Order”), this honorable Puerto Rico Energy Bureau (“Energy Bureau”) initiated procedures for LUMA and the Puerto Rico Electric Power Authority (“PREPA”) to complete three tasks. *See* Resolution and Order of December 31, 2020, pages 8-10. The first task assigned to PREPA was to create voltage level maps by May 31, 2021. The second task involved the creation of preliminary maps of interconnection capacity, to be completed by September 30, 2021. Finally, the third task consists of updating and completing a power grid inventory, to be completed by December 31, 2021. *See id.*
2. On October 1, 2021, in compliance with the December 31st Resolution and Order, LUMA informed this Energy Bureau that as of September 30, 2021, the interconnection capacity maps have been available for use by any customers or DG developers on the lumapr.com website (“October 1st Motion”).

3. As Exhibit 1 to the October 1st Motion, LUMA submitted both in the English and Spanish languages, a guide for users accessing and navigating the interconnection capacity maps.
4. On October 7, 2021, in accordance with that portion of the December 31st Resolution and Order that set a compliance hearing for October 12, 2021 and directed that copies of the presentation to be offered shall be filed at least three days prior to each hearing, LUMA submitted the Power Point TM presentation to be offered at the October 12th compliance hearing, entitled “*Plan for Distribution System Interconnection Capacity Map & Power System Inventory-Compliance Hearing*,” October 12, 2021. *See* Exhibit 1. The presentation was submitted in pdf format.
5. On October 12, 2021, LUMA personnel participated in the compliance hearing scheduled in this proceeding. Mr. Hugo Bashualdo, Director, Regulatory, offered LUMA’s presentation, which included a live demonstration of the features and functionalities of the interconnection capacity maps.
6. During the compliance hearing of October 12, 2021, Associate Commissioner Lillian Mateo Santos recommended that LUMA include in the interconnection capacity maps, the date when the maps were last published. LUMA personnel welcomed the recommendation and expressed that LUMA would work to include the referenced time stamp in the interconnection capacity maps.
7. As Exhibit 1 to this Motion, LUMA is submitting a rendering of the updated interconnection capacity maps, showing the field where LUMA added the date when the maps were last published.

WHEREFORE, LUMA respectfully requests that the Energy Bureau **take notice** of the update made to the interconnection capacity maps to include a field showing the date when the interconnection maps were last published.

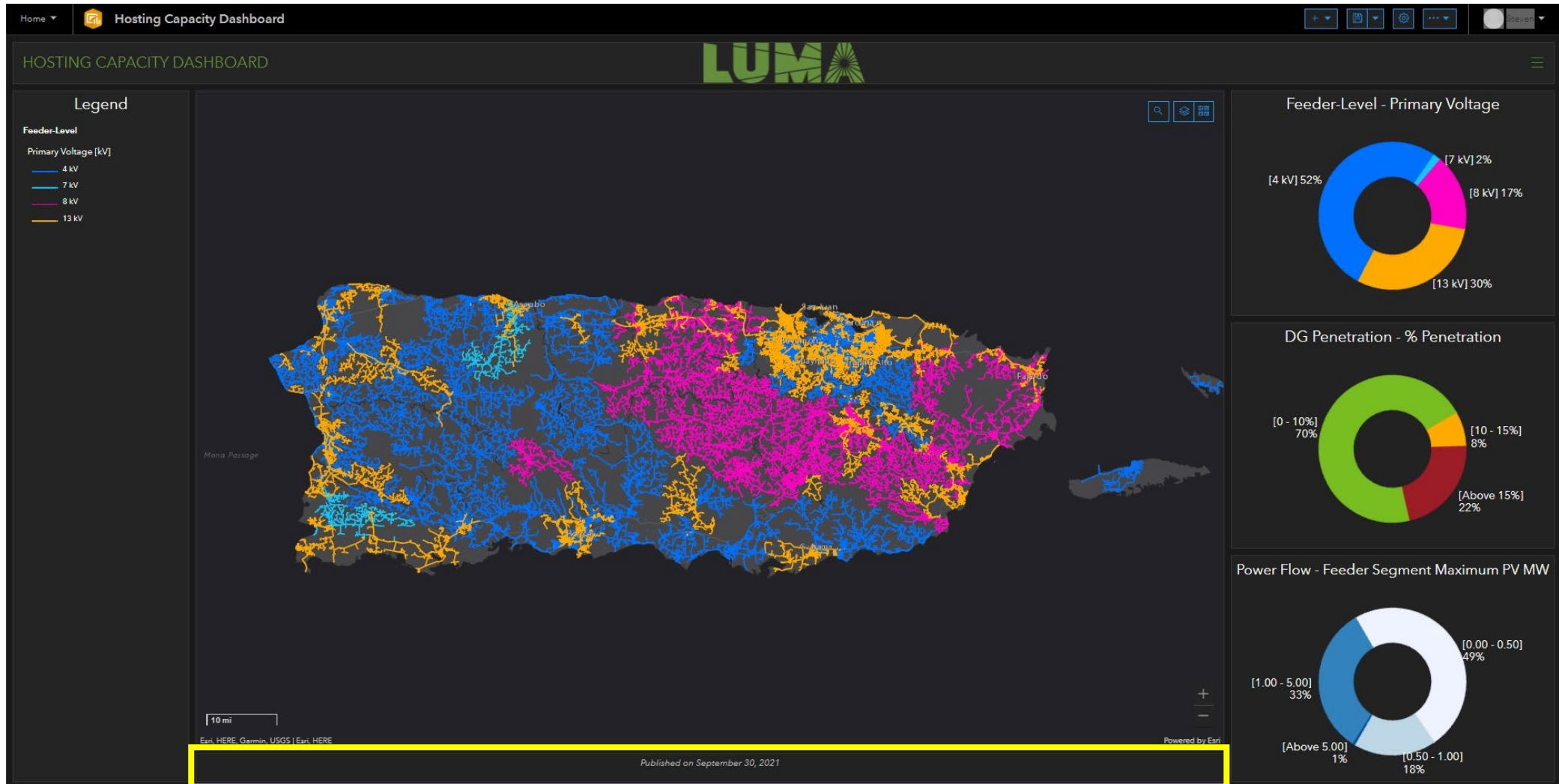
