
RESOLUTION AND ORDER

On January 14, 2022, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("January 14 Resolution") through which it amended the Procedural Calendar established through the December 22, 2021, Resolution¹ ("December 22 Resolution").

On January 28, 2022, LUMA Energy, LLC ManagementCo (as ManagementCo), and LUMA Energy ServCo, LLC² (as ServCo) (collectively, "LUMA"), filed a document titled *LUMA's Request for an Extension of Time to File Rebuttal Testimonies* ("January 28 Request"). LUMA states they expect to file several of the rebuttal testimonies by the deadline of February 1, 2022. However, LUMA understands that at least four rebuttal testimonies cannot be finalized until LUMA receives LECO's³ and ICPO's⁴ supplemental responses to several discoveries' requests. ICPO request to file its supplemental responses by February 1, 2022 and LECO requested to file its supplemental responses by February 4, 2022. Thus, LUMA asks the Energy Bureau to extend the timeframe to file the rebuttal testimonies to February 17, 2022. LUMA states that the request does not affect the current procedural calendar and counsel for LECO and ICPO have no objection to the request.

Upon review of LUMA's request, the Energy Bureau **GRANTS** LUMA until February 17, 2022, to file Rebuttal on Intervenor's written testimony.
