INFORMATIVE MOTION REGARDING LECO'S FIFTH AND SIXTH DISCOVERY REQUESTS TO LUMA

COME NOW, Comité Diálogo Ambiental, Inc., El Puente de Williamsburg, Inc. - Enlace Latino de Acción Climática, Inc., Alianza Comunitaria Ambientalista del Sureste, Inc., Coalición de Organizaciones Anti-Incineración, Inc., Amigos del Río Guaynabo, Inc., CAMBIO, and Sierra Club and its Puerto Rico chapter, and Unión de Trabajadores de la Industria Eléctrica y Riego (collectively, "LECO"), respectfully states and requests the following:

- On January 14, 2022, the Energy Bureau issued a Resolution and Order amending the procedural calendar ("January 14th Resolution and Order"). The Energy Bureau ordered LUMA to submit its witnesses' rebuttal testimonies on or before February 1, 2022.
- 2. On January 28, 2022, LUMA filed LUMA's Request for an Extension of Time to File Rebuttal Testimonies due to needed outstanding supplemental responses to the discovery requests issued by the Local Environmental and Civil Organizations ("LECO") and the Independent Consumer Protection Office ("ICPO"). LUMA requested that the Energy Bureau extend the timeframe to submit rebuttal testimonies to February 17, 2022.

- 3. On January 27, 2022, LECO filed a document titled Request to Amend the Procedural Calendar to Authorize Discovery on LUMA's Rebuttal Testimonies, to allow LECO a period of two to three weeks to conduct discovery on LUMA's rebuttal on Intervenors' written testimony and LUMA's rebuttal on intervenors' supplemental testimony.
- On January 31, 2022, the Energy Bureau issued a Resolution and Order ("January 31st Resolution and Order") granting LUMA until February 17, 2022, to file rebuttal testimonies on the intervenor's pre-filed direct testimonies.
- On February 1, 2022, LUMA submitted the pre-filed witnesses' rebuttal testimonies of Mr. Kalen Kostyk; Mr. Jorge Meléndez; Mr. Terry Tonsi; Ms. Melanie J. Jeppesen; and Mr. Brent Bolzenius.
- 6. On February 15, after reviewing LECO's request and LUMA's opposition, the Energy Bureau granted all parties a period of (10) ten days, starting February 17, to conduct discovery on LUMA's rebuttal on Intervenors' written testimony. The end of the discovery deadline, February 27th, fell on a Sunday. Regulation 8543 Section 1.09 allows LECO to file discovery on Monday, February 28th.¹
- 7. On February 17, LUMA submitted the pre-filed witnesses' rebuttal testimonies of Mr. Donald Hall (Senior Director Engineering & Asset

Management); Mr. Don Cortez (Vice President – Utility Transformation); Ms. Jessica Laird (Vice President of Customer Experience); Mr. Lee Wood (Director, Business Transformation); Mr. Branko Terzic; and Mr. Juan Lara.

8. On February 28, 2022, LECO submitted to LUMA the following requests: Fifth Set of Discovery Requests to LUMA and Sixth Set of Discovery Requests to LUMA. True and accurate copies of both sets are attached. **WHEREFORE**, LECO respectfully informs the Energy Bureau of the timely submittal of a fifth and a sixth set of discovery requests to LUMA.

FIFTH DISCOVERY REQUEST TO LUMA FROM LOCAL ENVIRONMENTAL AND CIVIL ORGANIZATIONS ON REBUTTAL TESTIMONIES

Comité Diálogo Ambiental, Inc., El Puente de Williamsburg, Inc. - Enlace Latino de Acción Climática, Inc., Alianza Comunitaria Ambientalista del Sureste, Inc., Coalición de Organizaciones Anti-Incineración, Inc., Amigos del Río Guaynabo, Inc., CAMBIO, Sierra Club and its Puerto Rico chapter, and Unión de Trabajadores de la Industria Eléctrica y Riego (Local Environmental and Civil Organizations, or "LECO"), by and through their legal counsel, hereby submit this Set of Discovery Requests to LUMA Energy LLC and LUMA Energy ServCo LLC (collectively, LUMA). Please forward responses to the discovery requests below to all attorneys of record within ten (10) days.¹ The General Instructions for these Requests are enclosed as well.

If any document is being withheld or redacted based on a claim of privilege, please also provide a privilege log identifying and justifying with specificity such withholding or redacting.

Questions on Jorge Menendez's Testimony:

- 1. Does OSHA prohibit an independent Bureau to use and impose OSHA metrics?
- 2. On pp. 7-8 you state that you do not agree with Mr. Irizarry's proposal that the Energy Bureau consider and approve a public safety metric on *Incidents, Injuries, and Fatalities,* can you explain the risks associated with electric lines?
- 3. How does LUMA propose to create an incentive program for employees without creating a perverse mechanism that will cause incidents to go unreported.

Questions to Terry Tonsi:

 P.6: Do you believe emergencies outside the scope of hurricanes or floods, specifically emergencies where live wires are present in public places, warrant a response that exceeds 60 minutes?

Questions to Melanie Jeppesen:

1. P.12: Please describe the process for a Puerto Rican residential electrical customer to file a formal complaint against LUMA.

- a. Is the process to file a formal complaint accessible to residential customers without internet access
- b. Is the process accessible to residential customers that do not often use computers or access the Internet?

Questions to Brent Bolzenius:

- 1. L.55: Can you explain the importance of vegetation management and the importance of having someone in charge of vegetation management?
- 2. L.55: Do you believe vegetation management is essential to public safety?
- 3. L.55: Was the LUMA Vegetation Plan adapted to the natural conditions of Puerto Rico, such as the existence of the Bejuco?
- 4. L.55: Are you aware of the different microclimates in Puerto Rico and the specificities needed to address and manage each one of them? Please provide a description of each microclimate, and LUMA's plan to tailor the vegetation management plan to each microclimate.
- 5. L.82-101: Are you proposing that metrics should be changed according to voltage level, region, line location (rural or urban)? In that direction, is it true that you argue metrics should be more specific, for example separating metrics according to urban or rural areas to fit the factors that shape those two different categories?
- 6. L.111: What is the percentage of failures tied to vegetation management and what is the percentage tied to others like debris etc.? Can you compare both?
- 7. Please refer to the statement on p. 9 of your testimony, quoting from the Vegetation Management Plan, that "LUMA's Vegetation Management Plan for PREPA's 230 kV and 115 kV system will generally be aligned with the NERC standard."
 - a. Why did LUMA choose to align the Vegetation Management Plan with the NERC standard?

- b. Please describe the benefits of aligning the Vegetation Management Plan with the NERC standard.
- c. Please list and describe each aspect of the Vegetation Management Plan which is <u>not</u> aligned with the NERC standard.

Questions to Donald Hall:

- 1. On page 12 you argue that "...current rates do not support improving everything at once." Does LUMA believe that current rates would not support transformation of the system to a reliable 21st century system? If not, what rate increases does LUMA believe are necessary to achieve a reliable 21st century system?
- 2. Please refer to the statement on p. 7 of your testimony where you state that "[t]he current PREPA T& D system is fragile and unreliable."
 - a. Did LUMA have an opportunity to inspect the T & D system before signing the OMA?
 - b. Did LUMA have an opportunity to inspect the T & D system in the "transition period"?
 - c. If answered in the affirmative, what were LUMA's findings?
 - d. If (a) and (b) were answered in the affirmative, please provide copies of all inspection documents.
- 3. L.126: Can you specify and describe the exogenous factors that you argue are out of LUMA's control and don't allow for metrics?

Questions to Don Cortez:

1. On p. 3 of your rebuttal testimony, you refer to your experience working with utilities and energy companies.

- a. Please list each utility you have worked for or advised during your career.
- b. Please list each energy company you have worked for or advised during your career.
- c. For each of the entities you listed in response to (a) and (b) above, please provide a description of the Performance Incentive Mechanisms, metrics, or any similar tools used by the entity during your time working for or advising that entity. Please also state whether you were involved in the design or implementation of each described Performance Incentive Mechanisms, metrics, or tool.
- 2. Please refer to your discussion of advanced meters, Energy Management Systems, Advanced Distribution Management System, and automated distribution switches on p. 8 of your testimony.
 - a. Does LUMA have a plan to implement these technologies?
 - b. Do you believe these are necessary to create a safe and reliable 21st century electric system in Puerto Rico?
- 3. Puerto Rico currently relies on long-distance transmission lines that carry power from large, centralized fossil fuel plants.
 - a. Do you believe that rebuilding these lines is part of the "significant investment to get to the point of a 20th century system" that you refer to on p. 7 of your testimony?
 - b. Do you believe that rebuilding these lines is necessary for a safe and reliable 21st century system?
- 4. On pp. 6-7 of your testimony, you state that Puerto Rico's T&D system requires "significant investment to get to the point of a 20th century system..." How long do you believe it will take LUMA to get Puerto Rico's T&D system "to the point of a 20th century system"?
- 5. How long will it take LUMA to "transform [Puerto Rico's grid] to a safe and reliable 21st century system"?
- 6. On p. 10 of your testimony, you describe LUMA's near-term task as "remediating and rebuilding the existing T&D System"

- a. Have you examined the performance of the existing system through Hurricane Maria and the seismic events starting in late 2018?
- b. If so, do you believe the system performed well through those challenges?
- c. Please describe your predictions of the performance of the existing T&D system, after being remediated and rebuilt, when the next earthquakes and hurricanes impact Puerto Rico.
- 7. Please refer to your statement on p. 19 of your testimony, that "LUMA's operations are aligned to meet the energy goals and policies of Puerto Rico..."
 - a. Are LUMA's operations aligned with the Renewable Portfolio Standard requiring 40% renewables by 2025? Please provide a detailed description of LUMA's plan to allow for integration of renewables into the grid to meet that requirement.
 - b. How would 40% distributed renewables coupled with batteries vary from utility scale renewables?
 - c. Would utility scale require more transmission and distribution infrastructure?
 - d. Are distributed renewables offsets to the T & D system?
 - e. Are LUMA's operations aligned with the Renewable Portfolio Standard requiring 60% renewables by 2040? Please provide a detailed description of LUMA's plan to allow for integration of renewables into the grid to meet that requirement.
 - f. How would 60% distributed renewables coupled with batteries vary from utility scale renewables?
- 8. Please refer to your discussion of Reduction in Network Line Losses on pp. 19-20 of your testimony. Provide all data and information that Mr. Cortez or LUMA has reviewed from PREPA regarding Reduction in Network Line Losses.
- 9. Please refer to your statement on p. 22 of your testimony that "LUMA examined the approximate number of appliance damage claims filed by customers under PREPA's operation of the T&D System from 2017 through May 2021 and under

LUMA's operation of the T&D System since June 1, 2021, whether proven to be valid or not."

- a. Provide all information in LUMA's possession regarding the claims examined.
- b. Who at LUMA conducted this examination?
- c. Please provide a detailed description of that person's or those persons' conclusions and findings from the examination.
- d. If a customer files an appliance damage claim, how would that person prove its validity?
- e. How would LUMA examine the validity of an appliance damage claim?
- 10. Please refer to your statement on p. 22 of your testimony that: "Based on records kept by PREPA and LUMA, the approximate total number of appliance claims have not varied greatly from FY 2017 through FY 2021."
 - a. Please provide those records.
 - b. Provide the exact number of claims in each month from FY 2017 through the present and provide the source for those numbers. If the month-bymonth numbers are not available, please provide annual figures.
- 11. On p. 25 of your testimony, you refer to the LUMA proposed SAIDI targets of 1,119; 932, and 746. Would LUMA earn incentives for reporting SAIDI under these targets?
- 12. Please refer to your statement on pp. 26-27 of your testimony that: "I should add that LUMA understands that this proceeding does not involve consideration of requirements to publish supporting data on the reliability indices that PREB tracks in Case NEPR-MI-2019-0007." Please provide the basis for that understanding.
- 13. On p. 30 of your testimony, you state that "Demarcation metering must be implemented before a precise measurement of energy losses can be calculated."
 - a. Please provide a detailed description of "demarcation metering."
 - b. Does LUMA have a plan to implement this technology?

- 14. On p. 31 of your testimony, you state that "System losses cannot be accurately calculated due to the lack of accurate metering at the legacy PREPA generation plants and for DG customers."
 - a. Do you believe that accurate calculation of system losses is necessary for a safe and reliable 20th century system?
 - b. Do you believe that accurate calculation of system losses is necessary for a safe and reliable 21st century system?
- 15. On pp. 33-34, you list several "activities and investments pursuant on T&D System infrastructure pursuant to Investment Programs approved by the Energy Bureau and the approved SRP."
 - a. Please state which of these activities and investments relate to integration of distributed solar. For each listed activity and investment, please explain how this activity or investment would improve integration of distributed solar into Puerto Rico's grid.
 - b. Please state which of these activities and investments relate to integration of distributed storage. For each listed activity and investment, please explain how this activity or investment would improve integration of distributed storage into Puerto Rico's grid.
- 16.On p. 11 of your testimony, you state that Witness Irizarry's comments on "service deterioration as a justification for imposition of additional penalties does not consider the current state of the T&D System."
 - a. Did LUMA inspect the T & D system before signing the OMA?
 - b. Were they aware of the circumstances the T & D system was in before signing?
 - c. Did LUMA evaluate the conditions of the electric system during the transition year?
- 17.L.305: You state that "the hosting capacity dashboard includes rudimentary interconnection capacity by distribution feeder with a dropdown menu that shows the following information [...]", by definition rudimentary implies an approximation, can you provide the raw data and how it was calculated to

achieve the results you provide? Are you opposed to a disclosure of not only the data but the calculations of how the information provided on MiLuma is calculated? Please disclose the date and the calculations of how the information provided on MiLuma is calculated.

- 18. Pp.19-20: Does LUMA have meters to measure the energy needed to (1) arrive at substations, (2) be injected and, (3) be consumed?
- 19. Ll.468-483: Can PREB not adopt a metric used by NERC? Is PREB prohibited from doing so, if so, who prohibits it?
- 20. Pp.26-27: Would customers that wish to access to their personal outage data have to enter MiLuma hourly to download the information? Is there any other way for customers to access personal outage data? Please provide separate answers for residential, commercial, and industrial customers.
- 21.Ll.611-629: When do you suggest it is adequate to propose load factor metrics? When do you think they should be considered?

Questions to Jessica Laird:

- Please provide a description of the costs incurred by PREPA and LUMA to date to conduct the J.D. Power customer satisfaction survey, with a breakdown of costs.
- 2. Please also provide a description of the annual costs going forward to conduct this survey.
- 3. Please provide all data and information obtained to date through the survey
- 4. Are the surveys in English or Spanish?

Questions to Lee Wood:

- 1. P.19: Has LUMA conducted any analysis or study on how the grid will sustain an increase in load due to the use of more electric vehicles? If so, please provide those analyses and studies. If not, please explain why those analyses have not been conducted.
- 2. P.19: Has LUMA conducted any analysis or study on how to adapt Puerto Rico's infrastructure to handle an increased load due to electric vehicles, without impeding a change towards distributed energy, energy storage and electric vehicle meters? If so, please provide those analyses and studies. If not, please explain why those analyses have not been conducted.
- 3. Please refer to your statement on p. 20 of your testimony that "AMI is a valuable technology that represents up to a \$1 billion investment that will take multiple years to implement and is currently unfunded."
 - a. Please provide the basis for your estimation that AMI could cost up to \$1 billion to implement in Puerto Rico.
 - b. Please describe the value of this investment.
 - c. Please describe the efforts of LUMA or PREPA to seek federal funding towards this investment. If those efforts have not been made, please explain why not.
 - d. Does Puerto Rico currently have any smart meters or Advanced Metering Infrastructure?
- 4. L.388: Is LUMA willing or able to provide clients with smart meters? If not, why not?

Questions to Branko Terzic:

1. Please disclose if you have had any previous contracts or services with LUMA or parent or subsidiary and who paid for those services.

- 2. Please disclose your service fees for providing this expert testimony.
- 3. Please refer to your statement on line 28 of your testimony that "Neither is LUMA's compensation tied to PREPA profit maximization."
 - a. Does LUMA have a goal of maximizing profit under the Transmission & Distribution OMA?
 - b. Please state the profits that LUMA has obtained to date through the OMA.
 - c. Please state the profits LUMA expects to receive from the OMA.
 - d. Please state the profits LUMA expects to receive through the proposed incentives in the draft Annex IX.

Questions to Juan Lara:

- 1. Please disclose if you have had any previous contracts or services with LUMA or parent or subsidiary and who paid for those services.
- 2. Please disclose your service fees for providing this expert testimony.
- 3. Please specify all publications related to electric utilities authored or coauthored by you.
- 4. Please specify all publications related to the area of performance metrics and or penalty schemes in electric utilities authored or co-authored by you.
- 5. Please specify if you have ever designed or helped designed or implement performance metrics and penalty schemes.
- 6. Please refer to your statement on p. 3 of your testimony that "Witness Alameda ignores warnings in the same literature he cites, pointing out that penalties may produce perverse incentive effects." Please describe the steps taken by utilities, as stated in the literature cited by Dr. Alameda, to correct and avoid those perverse incentive effects.
- L.304: You argue that Witness Alameda's statement "Reward and penalties are market-driven mechanisms, but within a regulator's framework." is confusing.

- a. Why is it confusing?
- b. Do regulators in the USA not operate on market driven economies just like Puerto Rico, where there is no price cap on energy services?
- 8. Ll.329-332: What is the difference between a "strong penalty component" and a "penalty component"?
- 9. L.358: Can you provide an explanation for the Coase Theorem?
- 10.L.460: You argue that the OMA includes penalties, but can you explain the penalties established in the OMA, aside from the termination of the contract under specific circumstances?
