**RESOLUTION AND ORDER**

On November 11, 2021, Mr. Raghu Murthy filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Notice of Appearance and Request for Notice* ("Notice of Appearance"). Mr. Murthy informed that he would appear as legal counsel along with attorneys Ruth Santiago, Pedro Saade and Laura Arroyo, on behalf of Comité Dialogo Ambiental, Inc., El Puente de Williamsburg, Inc., Enlace Latino de Acción Climática, Inc. Alianza Comunitaria Ambientalista del Sureste, Inc., Coalición de Organizaciones Anti-Incineración, Inc., Amigos del Río Guaynabo, Inc., CAMBIO and Sierra Club and it's Puerto Rico Chapter (collectively, "LECO") in the instant proceeding. Mr. Murthy also requested to be notified of all motions, resolutions, orders, and any other documents filed or entered hereafter.


On February 25, 2022, the Energy Bureau issued a Resolution and Order denying the Notice of Appearance because the administrative record of the instant case does not contain documentation demonstrating that Mr. Murthy has been granted leave to appear *pro hac vice* by the Puerto Rico Supreme Court. Therefore, the Energy Bureau denied the request.

On February 25, 2022, LECO filed a document titled *Motion for Reconsideration of the Denial of Raghu Murthy's Notice of Appearance* ("Motion for Reconsideration"). Through said Motion LECO informed the Energy Bureau that by inadvertence, the Resolution of the Supreme Court granting leave to appear *pro hac vice* was omitted from Mr. Murthy's Notice of Appearance and attached Puerto Rico's Supreme Court Resolution to the Motion for Reconsideration. Therefore, LECO requests the Energy Bureau to reconsider February 25 Resolution and Order and grant the Notice of Appearance.

On April 5, 2022, LECO filed a document titled *Motion Reiterating Motion for Reconsideration and to Vacate Order of the Denial of Raghu Murthy's Notice of Appearance*. LECO request that the Energy Bureau grant the relief requested in the Motion for Reconsideration.




