SUBJECT: Postponement of scheduled hearings.

RESOLUTION

On January 15, 2022, the Energy Bureau of the Puerto Rico Public Service Regulatory Board (“Energy Bureau”) issued a Resolution and Order (“January 15 Resolution”), through which, among other matters amended the procedural calendar of the instant case (“Procedural Calendar”). The Procedural Calendar included a Pre-Hearing Conference to be held on April 29, 2022 and Evidentiary Hearings from May 16 to May 20, 2022 (“Scheduled Hearings”).

The parties in this proceeding have filed several motions which impact the Procedural Calendar. These motions can be divided into four (4) subject groups: 1) requests to strike portions of the expert testimony of José Alameda-Lozada;¹ 2) LUMA’s² Response in Opposition to the December 22, 2021 Resolution and Order on Additional Metrics;³ 3) request to compel discovery responses from LECO’s expert witness, Augustin Irizarry;⁴ and 4) request to compel discovery from the Independent Consumer Protection Office (“OIPC”);⁵ The Energy Bureau is evaluating such motions and shall make the proper determinations shortly.

The Energy Bureau **DETERMINES** to postpone the Scheduled Hearings and all events on the Procedural Calendar until the Energy Bureau notifies its determinations on the mentioned motions and establishes an amended Procedural Calendar.


