**INFORMATIVE MOTION ON MATERNITY LEAVE**

**TO THE PUERTO RICO ENERGY BUREAU:**

1. The undersigned legal counsel, Laura B. Arroyo, represents in the captioned proceeding Comité Diálogo Ambiental, Inc., El Puente de Williamsburg, Inc. - Enlace Latino de Acción Climática, Inc., Alianza Comunitaria Ambientalista del Sureste, Inc., Coalición de Organizaciones Anti-Incineración, Inc., Amigos del Río Guaynabo, Inc., CAMBIO, and Sierra Club and its Puerto Rico chapter, and co-counsel to Unión de Trabajadores de la Industria Eléctrica y Riego (“Local Environmental and Civil Organizations”, or “LECO”).
2. From April 29 to October 10 the undersigned counsel will be out for maternity leave. During that period the undersigned counsel will not be able to provide legal services to LECO or participate in the case.

5. The undersigned counsel respectfully requests that the Energy Bureau and the other parties take notice and grant a temporary withdrawal of legal representation. Additionally, a request that all notifications directed to the undersigned counsel of the orders and resolutions and documents filed in this case be suspended until my return. A proper Notice of Appearance will be filed at that moment.

Wherefore, it is respectfully requested that PREB take notice of the foregoing and grant the specified relief.
