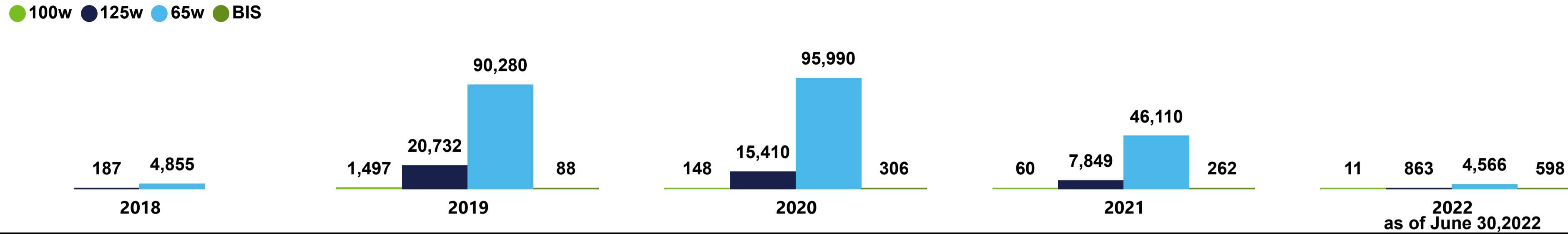

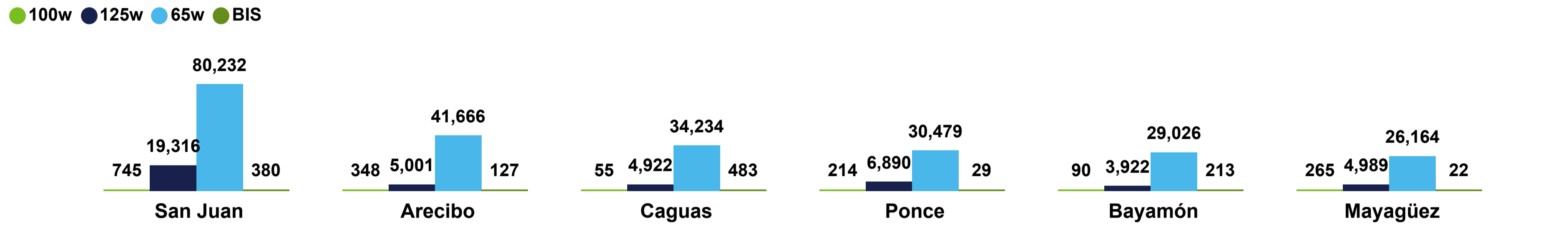


Streetlights Back in Service by Year

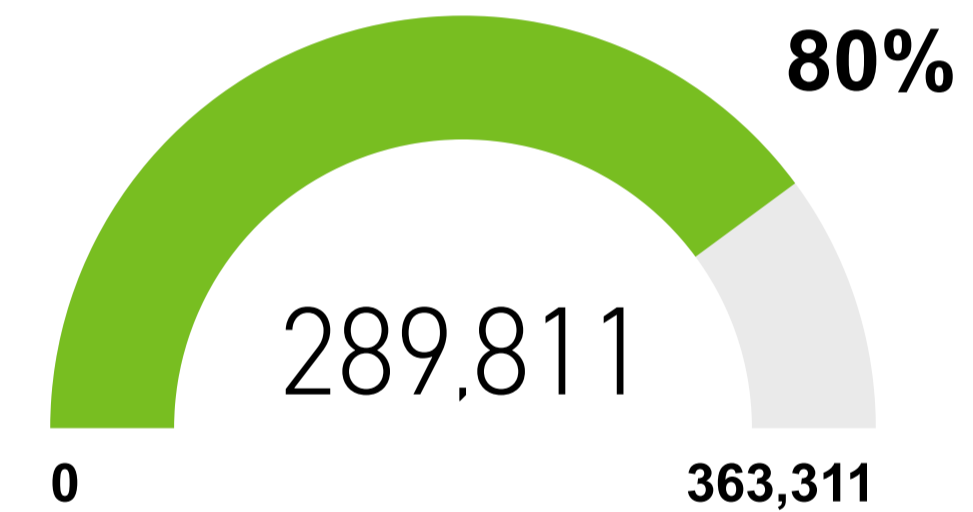

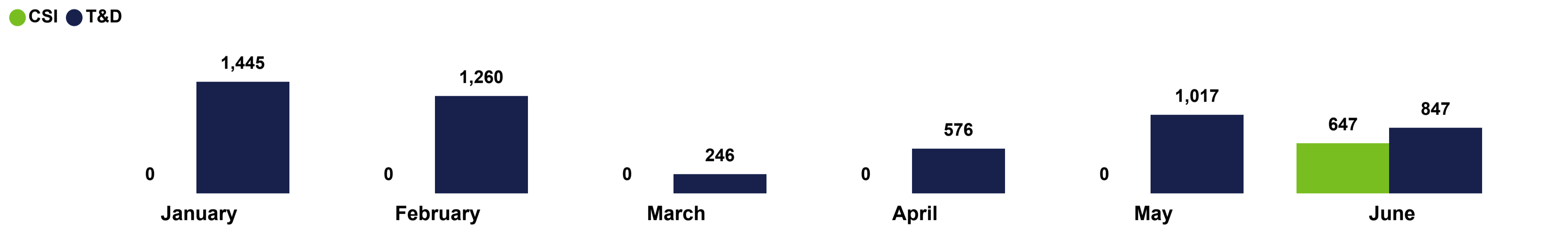
Total Streetlights Back in Service by Region as of June 30, 2022



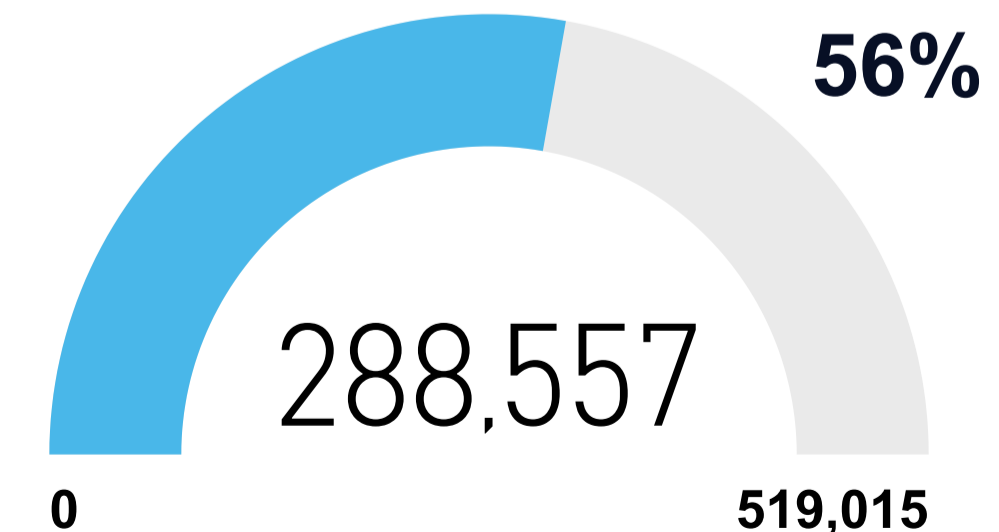
Total Back in Service
