**RESOLUTION**

On June 13, 2022 the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("June 13 Order") in which it requested ORIANA ENERGY, LLC., ("ORIANA") to clarify discrepancies found between the *Personal Information Form* ("Form NEPR-B01") and the *Form 556 of the Federal Energy Regulatory Commission* ("FERC Form 556"). In the June 13 Order, the Energy Bureau also order ORIANA to file: (i) evidence of payment for the filing fee of Form NEPR-B01 (Personal Information Update), and (ii) its audited financial statements.

On June 17, 2022 ORIANA filed a response ("June 17 Response") to the June 13 Order through which ORIANA: (i) clarified<sup>1</sup> the discrepancies between Form NEPR-B01 and FERC Form 556, (ii) presented evidence of payment of the filing fee of Form NEPR-B01, and (iii) filed its audited financial statements.

The Energy Bureau **DETERMINES** ORIANA complied with the June 13 Order.

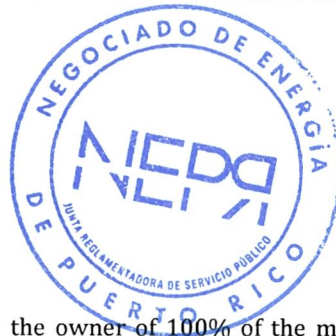
