COME NOW LUMA Energy ServCo, LLC and LUMA Energy, LLC (collectively "LUMA"), through the undersigned legal counsel, and respectfully submit the following:

LUMA respectfully submits that the motion titled *Confidential Informative Motion and Request* for the Energy Bureau to Consider LUMA's Comments on Proposed PPOA submitted by PREPA on July 1, 2022, and Require Modifications Thereof Accordingly enclosed as Attachment A of this Request and Exhibits 1 and 2 thereof are confidential because these documents refer to terms of contracting between PREPA and a generator that are not final and might place PREPA in a competitive disadvantage with respect to other similar large scale generators, including those with which negotiations are still under way in connection with the Tranche 1 procurement process.
