## **ORDER**

On August 10, 2022, the Respondent, Luma Energy Servco, LLC, filed an Answer to the Complaint. As so, we hereby scheduled the Pre-Hearing Conference on **Wednesday**, **September 22, 2022, at 9:00 a.m.**, in accordance with the provisions of Section 9.01 of Regulation 8543. We also scheduled the Administrative Hearing on **Wednesday**, **September 22, 2022, at 9:30 a.m.** Both hearings will be held in the Puerto Rico Energy Bureau Conference Room, located in the World Plaza Building, 268 Ave. Muñoz Rivera, Plaza Level, Suite 202, San Juan, Puerto Rico.

The parties will have ten (10) days from the date of notification of this Order, to report any conflict with the above dates, in which case they must provide three (3) dates for the celebration of the Pre-Hearing Conference and the Administrative Hearing. The parties are warned that failure to appear at the Administrative Hearing may result in the dismissal of the case or the elimination of the allegations, and for this purpose, the Bureau may issue any order it deems appropriate.

The parties will have until Friday, September 2, 2022, to conclude the discovery of evidence process per Article VIII of Regulation 8543. If disputes arise regarding the discovery of evidence process, the parties are directed to meet and try in good faith to resolve the matters before filing any motion for our consideration. Disputes related to the discovery of evidence process will only be dealt with after the parties certify that a reasonable effort has been made to resolve them.

Finally, the Report required by Section 9.01 (B) of Regulation 8543 must be submitted using the Energy Bureau's electronic filing system at the following address <a href="https://radicacion.energia.pr.gov">https://radicacion.energia.pr.gov</a>. on or before September 9, 2022. The parties are required to make all necessary efforts to achieve the greatest number of factual and evidentiary stipulations. If the report is not received on the date and in the manner required, the Pre-Hearing Conference shall be suspended, and the Bureau may impose sanctions.
