MOTION REQUESTING AMENDMENT OF THE PROCEDURAL CALENDAR

TO THE BUREAU:

Now comes Instituto de Competitividad y Sostenibilidad Económica de Puerto Rico (ICSE) represented by appearing counsel and respectfully requests:

On July 29, 2022 the Energy Bureau (PREB) issued a Resolution and Order commencing the review of LUMA’s proposed budget for fiscal year 2023. It furthermore established the following Procedural Calendar:

Date	Phase
August 12, 2022	Filing of LUMA’s Presentation for the Virtual Technical Conference
August 17, 2022	Virtual Technical Conference
August 22, 2022	Filing of Revised and/or Additional Information Required by the Energy Bureau
August 24, 2022	Virtual Public Hearing/Filing of Comments by General Public Due

There is a five-day timeframe between every due date of the Calendar with the exception of the timeframe between the date for the Filing of Revised and/or Additional Information Required by the Energy Bureau and the date for participation in the Virtual Public Hearing/Filing of Comments by the General Public. This amounts only to two (2) days.

Since the public lacks the expert knowledge nor the resources LUMA enjoys, it is necessary that they are provided an adequate timeframe to react to the last filings. ICSE considers that a reasonable term would be comprised of ten (10) days from the last filing date (August 22, 2022), i.e., September 1st, 2022. As a minimum, the public should be provided the same amount of time LUMA has between due dates (five days).

WHEREFORE, it is respectfully requested to consider the aforementioned amendment to the Procedural Calendar of the present case.
