**MOTION FOR EXTENSION OF TIME TO FILE MEMORANDUM OF LAW IN
SUPPORT OF CONFIDENTIAL TREATMENT OF MOTION FILED BY LUMA ON
JULY 26, 2022**

COME NOW LUMA Energy, LLC and LUMA Energy ServCo, LLC (jointly “LUMA Energy”), through the undersigned counsel, and respectfully state and request the following:

1. On July 26, 2022, LUMA Energy filed a *Confidential Informative Motion and Request For The Energy Bureau To Consider LUMA’s Comments to Proposed PPOA Submitted By PREPA On July 1, 2022, and Require Modification Thereof Accordingly* (“Confidential Informative Motion”) submitting as attachments Exhibits 1 and 2.

2. That same day, LUMA Energy filed a *Request For Confidential Treatment of Attachment A* (the “July 26th Request”) requesting confidential treatment of the *Confidential Informative Motion* (referred to as “Attachment A”) and Exhibits 1 and 2 of the *Confidential Informative Motion*, pursuant to the Energy Bureau’s Policy on Management of Confidential Information, CEPR-MI-2016-0009 issued on August 31, 2016, and partially amended on September 20, 2016, and indicating it would submit a Memorandum of Law in support of this request within the following ten (10) days in accordance with the Policy.

3. LUMA Energy is in the process of preparing the mentioned Memorandum of Law, and despite our best efforts, additional time is needed to complete it for submittal to this honorable

Energy Bureau. LUMA anticipates that it will be able to complete this effort within the next five (5) workdays.

WHEREFORE, LUMA Energy hereby requests an extension of time of (5) workdays, up to and including August 12, 2022, to file the Memorandum of Law in support of the request for confidential treatment of Confidential Informative Motion included as Attachment A of the July 26th Request and its Exhibits 1 and 2.
