RESOLUTION

On June 13, 2022 the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("June 13 Order") in which it requested CEN JUNCOS SOLAR, LLC ("CEN Juncos Solar") to file its compiled Financial Statements pursuant Section 4.02(E) of Regulation 8701¹.

On June 28, 2022 CEN Juncos Solar filed a document titled *Motion in Compliance with Resolution and Order dated June 13, 2022, and Request for Confidential Treatment of Information* ("June 28 Motion") as response to the June 13 Order. CEN Juncos Solar attached the consolidated Financial Statements² of Juncos Solar Holdings, LLC to the June 28 Motion. Juncos Solar Holding, LLC is the 100% owner of CEN Juncos Solar.³ In the June 28 Motion, CEN Juncos Solar also requested a Confidential Treatment of its Financial Statements. CEN Juncos Solar argues if this information becomes public its company would suffer economic harm and would be in a disadvantageous position before its competitors.

Upon the review of the June 28 Motion, the Energy Bureau **DETERMINES** CEN Juncos Solar complied with the June 13 Order. The Energy Bureau also **GRANTED** a Confidential Treatment to the CEN Juncos Solar Financial Statements, pursuant Section 6.15 of Act 57-2014.⁴
