**SUBJECT:** Re-Submittal of Exhibit 1 filed on September 1, 2022 with Technical Repairs; Request for Substitution of Original Exhibit 1; and Request to Postpone Compliance Technical Hearing No. 3.

**RESOLUTION**

On September 1, 2022, LUMA Energy ServCo, LLC ("LUMA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion Submitting Draft Phase I EV Plan and Request to Postpone Compliance Technical Hearing No. 3 and Concomitant Deadline to Submit Revised Phase I EV Plan*, which included an Exhibit 1 ("September 1 Request"). Exhibit 1 of the September 1 Request includes LUMA's draft Phase I EV Plan ("Draft Phase I EV Plan"). LUMA indicated that the Draft Phase I EV Plan supports the deployment of infrastructure to enable equitable and accessible use of EV's while advancing the remediation of the electric system to improve reliability and resiliency for customers.<sup>1</sup> LUMA requested to postpone the Compliance Technical Hearing No. 3 scheduled for September 15, 2022 until September 29, 2022 and postpone the revised Phase I EV Plan two weeks from the date of the rescheduled Compliance Technical Hearing.<sup>2</sup>

On September 2, 2022, LUMA filed before the Energy Bureau a document titled *Motion Re-Submitting Exhibit 1 Filed on September 1, 2022 with Technical Repairs and Requesting Substitution of Original Exhibit* ("September 2 Motion"). Through said September 2 Motion, LUMA states that they identified technical issues with some of the hyperlinks for references to figures and external websites in the Exhibit 1 to the September 1 Request which resulted in some of the links not working properly. Furthermore, LUMA informs that they have addressed these technical issues and re-submitted the Exhibit 1 with the corrected links ("Amended Exhibit 1").

Upon review of LUMA's request and to allow sufficient time for the Energy Bureau, LUMA and the public to prepare and provide the most efficient information and participation, the Energy Bureau **RESCHEDULES** the Compliance Technical Hearing No. 3 to be held **October 12, 2022, at 10:00 a.m.** Therefore, the revised Phase I EV Plan **SHALL** be filed on or before **October 28, 2022.**

The Energy Bureau **GRANTS** LUMA's and **ORDERS** the Energy Bureau's Clerk to substitute the Exhibit 1 to the September 1 Request with the Amended Exhibit 1.




