SUBJECT: Resolution and Order regarding Request for Continuance of Technical Conference Scheduled for September 27, 2022, filed by the Puerto Rico Electric Power Authority; Procedural Calendar Amendment.

RESOLUTION AND ORDER

On September 7, 2022, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution through which it amended the Procedural Calendar and added an additional day to conduct the Virtual Technical Conference, if warranted. ("September 7 Resolution"). As per the amended Procedural Calendar, the Virtual Technical Conference was scheduled to take place on **Tuesday, September 13, 2022, and Wednesday, September 14, 2022, from 10:00 a.m. to 5:00 p.m.**

On September 9, 2022, LUMA Energy, LLC and LUMA Energy ServCo, LCC ("LUMA") filed before the Energy Bureau a document titled *Urgent Request to Re-Schedule Second Day of Technical Conference and for Issuance of Agenda* ("September 9 Motion"). Through the September 9 Motion, LUMA stated that several of LUMA's and the Puerto Rico Electric Power Authority's ("PREPA") witnesses and management personnel were not available to appear before the Energy Bureau on September 14, 2022.¹ LUMA further indicated that upon conferring with PREPA, **the earliest availability for both LUMA and PREPA is on September 27, 2022**.²

On September 13, 2022, the first day of the Technical Conference was held as scheduled. One day for the Technical Conference was insufficient and considering the availability of both parties as indicated in the September 9 Motion, the Energy Bureau issued a bench order through which it rescheduled the second day of the Technical Conference for **Tuesday**, **September 27, 2022** (from 10:00 a.m. to 5:00 p.m.). Furthermore, the Energy Bureau **ORDERED** LUMA to submit certain information and/or documents on or before 5:00 p.m. of September 23, 3022.

On September 16, 2022, PREPA filed before the Energy Bureau a document titled *Request for Continuance of Technical Conference Scheduled for September 27, 2022* ("September 16 Motion"). Through the September 16 Motion, PREPA informed that Mr. Lucas Porter, its leading financial advisor and key witness to appear during the referenced Technical Conference, was not available on September 27, 2022.³ PREPA stated that Mr. Porter was available to appear on any date from October 7, 2022 onwards and thus requested the Energy Bureau to grant a continuance of the second day of the Technical Conference.⁴

Upon review of the September 16 Motion and taking notice that LUMA and PREPA or focused on the recovery of the electric system due to Hurricane Fiona, the Energy Bureau **RESCHEDULES** the second day of the Technical Conference for **Tuesday**, **October 18**, **2022** (from 10:00 a.m. – 5:00 p.m.). Accordingly, the Energy Bureau **AMENDS** the Procedural Calendar of the instant case as follows:

Additionally, the Energy Bureau **ORDERS PREPA** to file before the Energy Bureau on or before **Friday**, **October 7**, **2022**, i) all documentation submitted before the Financial Oversight and Management Board for Puerto Rico ("FOMB") pertaining Fiscal Year 2022, including the four (4) quarterly reports for FY 2022; and (ii) all documents filed with FOMB regarding Fiscal Year 2023 Certified Budget as well as the responses provided by the FOMB.

The Energy Bureau **WARNS** LUMA that noncompliance with this Resolution and Order, regulations and/or applicable laws may carry the imposition of fines and administrative sanctions of up to twenty-five thousand dollars (\$25,000.00) per day, in accordance with Art. 6.36 of Act 57-2014.⁹
