RESOLUTION AND ORDER

I. Introduction

On June 21, 2022, LUMA Energy, LLC and LUMA Energy ServCo, LLC ("LUMA") submitted a Proposed Energy Efficiency ("EE") and Demand Response ("DR") Transition Period Plan ("Proposed TPP") to the Energy Bureau of the Public Service Regulatory Board ("Energy Bureau").

On June 28, 2022, the Energy Bureau initiated this proceeding for the review of LUMA's Proposed TPP.

On June 29, 2022, the Energy Bureau held a workshop in this proceeding at which LUMA presented a summary of the Proposed TPP.

On July 13, 2022, Vermont Energy Investment Corporation ("VEIC") and Solar and Energy Storage Association of Puerto Rico ("SESA-PR") filed comments on the Proposed TPP in response to the Energy Bureau's request.

This Resolution and Order outlines additional steps for public input, and for the Energy Bureau to collect further information from LUMA, to aid in the Energy Bureau's consideration of the Proposed TPP.

II. Implementation of the Proposed TPP

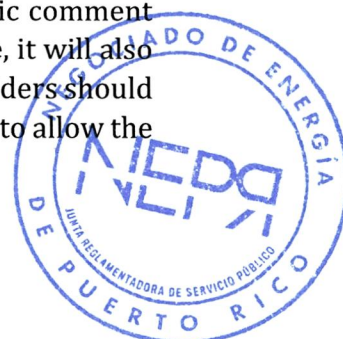
The Regulation for Energy Efficiency, along with the Energy Bureau's Order of February 1, 2022, in proceeding NEPR-MI-2021-0006, requires that LUMA begin implementation of its Proposed TPP on or before October 1, 2022, unless otherwise ordered by the Energy Bureau. Today's order does not change that instruction, and LUMA should proceed to implement its Proposed TPP until otherwise ordered by the Energy Bureau. The Energy Bureau is aware that the early phases of the Proposed TPP include the identification and contracting of an implementation contractor, along with the start of education and outreach activities. The Energy Bureau's examination of, and potential requirement of amendments to, the Proposed TPP will primarily address activities to be undertaken after the Energy Bureau's final order on the TPP, which is expected to be issued in the late fall of 2022.

III. Technical Conference

The Energy Bureau will hold a Technical Conference regarding the Proposed EE and DR Transition Period Plan on **Friday, November 4, 2022, at 10:00am**. In recognition of the health dangers presented by COVID-19, the Workshop will be held in a virtual meeting room using Microsoft Teams. Interested parties should email secretaria@jrsp.pr.gov to obtain the link and instructions for participation. The Technical Conference will also be streamed on the Energy Bureau's YouTube channel.

IV. Requests for Information and Initial Comments

During the week of October 3, the Energy Bureau will issue questions for public comment regarding the Proposed TPP and potential changes to the TPP. At the same time, it will also issue a set of formal requests for information to LUMA. LUMA and other stakeholders should expect to respond to these requests within two weeks of their issuance, in order to allow the




Energy Bureau to adequately prepare for the Technical Conference. LUMA and other stakeholders may also submit any additional comments at that time. This round of comments, including responses to questions, will be considered the initial comment period.

V. Reply Comments


The Energy Bureau will also welcome reply comments by November 14, 2022, addressing the initial comments filed by other stakeholders as well as the contents of the November 4 technical conference.

The details for submission of these comments will be included in the relevant Resolution.
