SUBJECT: Costa Sur Outage Event, April 6, 2022, Root Cause Evaluation. Request of Information to LUMA and PREPA.

RESOLUTION AND ORDER

I. Introduction

On April 6, 2022, at approximately 8:40pm, an event in the electrical system leaves approximately 1.2 million clients without electrical power ("Incident").¹ LUMA², the transmission and distribution system operator of the Puerto Rico electric grid, posted several messages at its WEB Page to inform about the Incident.³ In compliance with Section 5.14(b) of the Operation and Maintenance Agreement⁴ ("OMA"), LUMA filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a report of the Incident, updated at 12:00pm of April 7, 2022 ("Emergency Notification").

On April 8, 2022, the Energy Bureau issued a Resolution and Order ("April 8 Order") to initiate an Investigative Procedures of the Incident. The Energy Bureau also ordered LUMA to file the Final Report of the Incident on or before April 18, 2022.

On April 18, 2022, LUMA filed a Motion Submitting Updated Report and Request for Confidential Treatment ("April 18 Motion"). LUMA informs it "is conducting a thorough investigation of the April 6th Incident, including an independent forensic assessment of the failed equipment. To this end, LUMA hereby informs that, a third-party investigation firm, Exponent, has been retained to assist with the investigation and analysis of the April 6 Incident"⁵.

On October 4, 2022, LUMA filed a Motion Submitting Root Cause Evaluation of the April 6 Incident and Request for Confidential Treatment ("October 4 Motion"). The October 4 Motion includes the Costa Sur Outage Event, April 6, 2022, Root Cause Evaluation⁶ performed by Exponent.

According to Section 15.01 of Regulation No. 85437, the Energy Bureau "by itself or through a designated person, may carry out the investigations it deems pertinent to ensure compliance with public energy policy".

II. Independent Assessment of the Costa Sur Outage Event, April 6th 2022, Root Cause Evaluation

The Energy Bureau is the regulatory entity responsible for overseen and ensure the full execution and implementation of the Puerto Rico Energy Public Policy.⁸ Under Act 57-2014, the Energy Bureau is responsible for establishing and implementing the regulatory actions to guarantee the capacity, reliability, safety, efficiency and reasonability of electricity rates of Puerto Rico.⁹ In addition, the Energy Bureau has jurisdiction and broad powers to investigate any matter that refers to compliance with laws that affect the execution of the public energy policy.¹⁰ the public policy establishes that every consumer has the right to have a reliable, stable and excellent electricity service.¹¹

According to Section 15.01 of Regulation No. 8543^{12} , the Energy Bureau "by itself or through a designated person, may carry out the investigations it deems pertinent to ensure compliance with public energy policy".

As part of its Investigative Procedures, the Energy Bureau has acquired the professional services of Electric Power Research Institute, Inc. ("EPRI") to provide Major Disturbance Investigation Support of the April 6th, 2022, electric power blackout in Puerto Rico. EPRI is an independent, nonprofit organization with a mission to deliver objective, unbiased research, and development for public interest with focus on enhancing quality of life through making electric power safe, reliable, affordable, and environmental responsible.

III. Conclusion

The Energy Bureau **ORDERS** LUMA, **within a term of five (5) days** from the notification of this Resolution and Order to submit the following documents:

- (2) *Independent Engineering Report PREPA Transmission and Distribution System* prepared by Sargent & Lundy, Report No. SL-014468.TD, dated June 2019.

- (4) PREPA Letter Análisis Estadístico y Proyectado de la Conservación de Equipos Eléctricos de la Subdivisión de Conservación Eléctrica; dated October 19, 2016.
- (5) LUMA Substation Assessment Costa Sur; dated July 26, 2021
- (6) Operating Procedure Number 401-C.S.5&6, dated September 1, 1977.

The Energy Bureau **ORDERS** PREPA and LUMA to cooperate with EPRI in all matters described and any further pertinent requests issued directly from EPRI.

The Energy Bureau **WARNS** PREPA and LUMA that, pursuant to Article 6.36 of Act 57-2014, noncompliance with the Energy Bureau's orders or applicable legal requirements may carry the imposition of administrative fines of up to twenty-five thousand dollars (\$25,000) per day, per violation and/or other sanctions that the Energy Bureau may deem appropriate.
