
Subject: Designation of Hearing Examiner

DESIGNATION OF HEARING EXAMINER

On July 3, 2018, the Puerto Rico Energy Bureau (“Bureau”) issue a Resolution authorizing Counsel Dennis Seilhamer Anadón to serve as Hearing Examiner in the Formal Bill Review Proceedings pursuant the provisions of Regulation 8863¹ and in the Claims proceedings pursuant the provisions of Regulation 8543².

Counsel Seilhamer Anadón has been appointed by the Bureau as an Examiner to conduct the proceedings of the above captioned case. Attorney Seilhamer shall have the authority to (1) administer oaths and take depositions; (2) issuing subpoenas; (3) receive and evaluate evidence; (4) preside hearings; and (5) hold conferences to streamline procedures. This does not include the imposition of administrative fines.

The appointment of Counsel Seilhamer Anadón will remain in force until the Bureau expresses the contrary.
