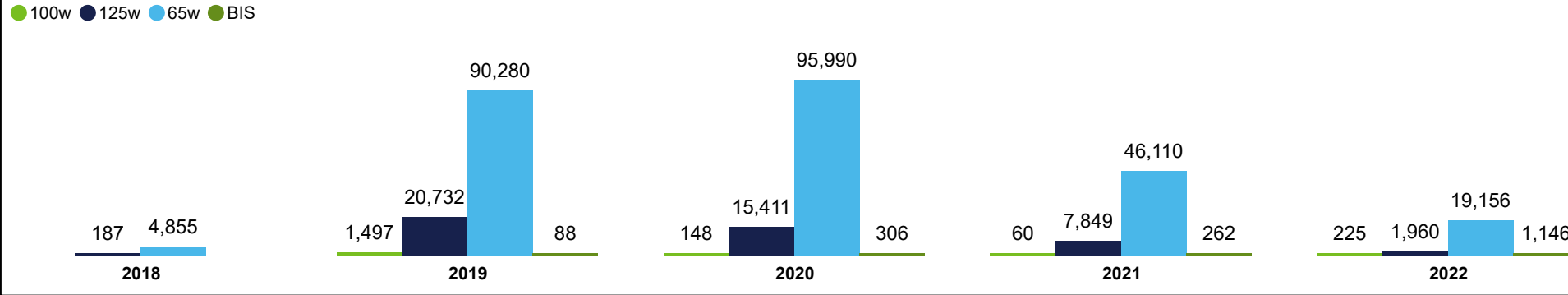

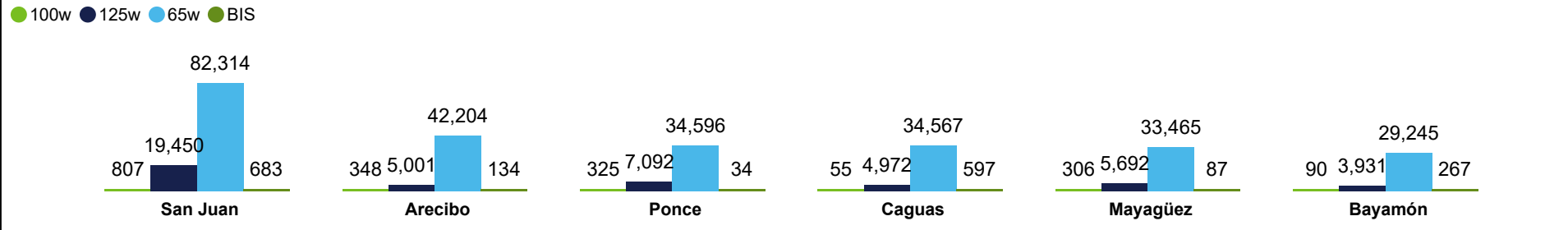

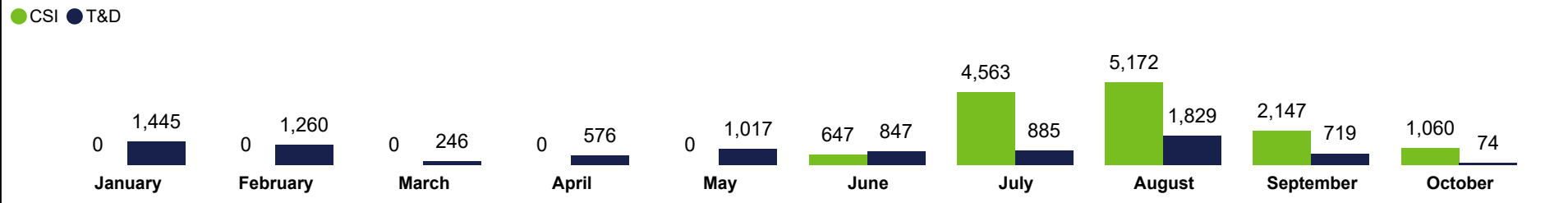
Streetlights Back in Service by Year
