SUBJECT: LUMA's Fourth Update on Stabilization Plan and Request to Release LUMA from the Requirement to File an Update on January 2, 2023.

RESOLUTION AND ORDER

On October 12, 2022, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("October 12 Order"), ordering LUMA¹ to develop a stabilization plan, as a direct response to Hurricane Fiona, in coordination with the Federal Emergency Management Agency ("FEMA") and the Puerto Rico Electric Power Authority ("PREPA") to address any baseload generation inadequacy or shortfall that affects the dispatch availability and has the potential to cause load shedding or blackout event of the electric system ("Stabilization Plan"). The October 12 Order directed LUMA to submit on the 1st and 15th day of each month from the notice of the October 12 Order, an updated report addressing the efforts conducted by LUMA to assure the completion of the Stabilization Plan.²

And Jane

On December 15, 2022, LUMA filed before the Energy Bureau a document title *Fourth Update* on Stabilization Plan and Request to Release LUMA from the Requirement to File an Update on January 2, 2023 ("December 15 Motion"), in which LUMA submitted the Forth Update of the Stabilization Plan.³ In its December 15 Motion, LUMA seeks to be released from the requirement to file an Update Report for the Stabilization Plan due on January 2, 2023, in consideration of the upcoming Christmas and New Year's holidays which shall limit the available time for LUMA to prepare a report due on January 2, 2023. LUMA shall continue to work with the governmental partners in the Stabilization Plan and LUMA will timely inform the Energy Bureau if any new developments on the Stabilization Plan arise before the next scheduled January 15, 2023 update.⁴.

Upon review of LUMA's arguments, the Energy Bureau **GRANTS** LUMA's request and **ORDERS** LUMA's to file the next Update Report for the Stabilization Plan, no later than **January 15, 2023.**

The Energy Bureau **WARNS** LUMA's that noncompliance with any provision of this Resolution and Order may result in the imposition of fines pursuant to Act 57-2014⁵ and applicable Energy Bureau's regulations and any other appropriate administrative sanctions, as deemed appropriate by the Energy Bureau.
