**RESOLUTION**

On April 8, 2021, the Energy Bureau of the Puerto Rico Public Service Regulatory Board (“Energy Bureau”) issued the original procedural calendar for the instant proceeding. The Energy Bureau noted that it would opportunistically inform whether the hearing be held in person or remotely.



On June 4, 2021, the Energy Bureau determined that the Evidentiary Hearing would be held remotely via the Microsoft Teams platform due to the ongoing pandemic.

On October 14, 2022, the Energy Bureau issued a Resolution and Order through which, among other things, it amended the procedural calendar for the instant proceeding, establishing that the Evidentiary Hearing would be held from February 7, 2023 to February 10, 2023.

Through this Resolution, the Energy Bureau **MODIFIES** the format of the Evidentiary Hearing and sets forth that the hearing will be conducted using a hybrid model; thus, participants that are not in Puerto Rico shall attend the hearing remotely. All other participants shall attend the hearing in person. The Energy Bureau will provide a link and instructions to access the hearing remotely, by request, to the participants that cannot attend in person.

Notwithstanding the above, the Energy Bureau **INFORMS** that the Commissioners, the Examiner Officer, and the Energy Bureau’s consultants shall attend the hearing in person.
