RESOLUTION

On February 1, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued the Agenda of the Evidentiary Hearing to be held in the instant proceeding from February 7 to February 10, 2023.

On February 2, 2023, LUMA Energy, LLC and LUMA Energy ServCo, LLC (jointly referred to as "LUMA") filed before the Energy Bureau a document titled *Motion Requesting Witness Jessica Laird to be Included as Witness for the Major Outage Events Category* ("February 2 Motion"). Through the February 2 Motion, LUMA requested that Jessica Laird be included as a witness for the Major Outage Events category set for discussion on Friday, February 10, 2023, as she offered direct testimony on the referenced topic on August 18, 2021.¹

Upon review of the LUMA February 2 Motion, on a separate Resolution issued February 3, 2023, the Energy Bureau granted LUMA's request and stated that it would amend the Agenda.
