RESOLUTION AND ORDER

On February 1, 2023, the Financial Oversight and Management Board for Puerto Rico ("FOMB") wrote a letter in response to a January 11, 2023 letter, wherein the Puerto Rico Electric Power Authority ("PREPA") responded to the FOMB's request for information in connection with PREPA's request to amend and recertify the FY2023 PREPA Certified Budget to address certain operational and maintenance needs ("February 1 Letter"). In its February 1 Letter, the FOMB acknowledged receipt of the information submitted by PREPA, including the formal response letter, and supporting documentation.

Further, the FOMB advised PREPA it must submit any budget amendment request before the Energy Bureau for review and approval pursuant the existing regulatory framework under Also, the FOMB clarified that, once the Energy Bureau issues a determination on whether to approve, deny, or modify PREPA's request, PREPA should submit a budget amendment request reflecting PREB's determination to the FOMB for review and approval. Last, the FOMB explained that, upon review of such request, it may issue a budget revision schedule pursuant to Section 202(a) of PROMESA.

Through this Resolution and Order, the Energy Bureau ORDERS PREPA to present to LUMA for LUMA to file with the Energy Bureau all the documentation PREPA submitted in connection with its January 11, 2023, letter to the FOMB, within five (5) days of the notification of this Resolution and Order.

Also, the Energy Bureau ORDERS PREPA to include in the foregoing submittal to LUMA a complete and exact copy of the contracts it has subscribed within the past six (6) months regardless of their amount, within five (5) business days of the notification of this Resolution and Order.
