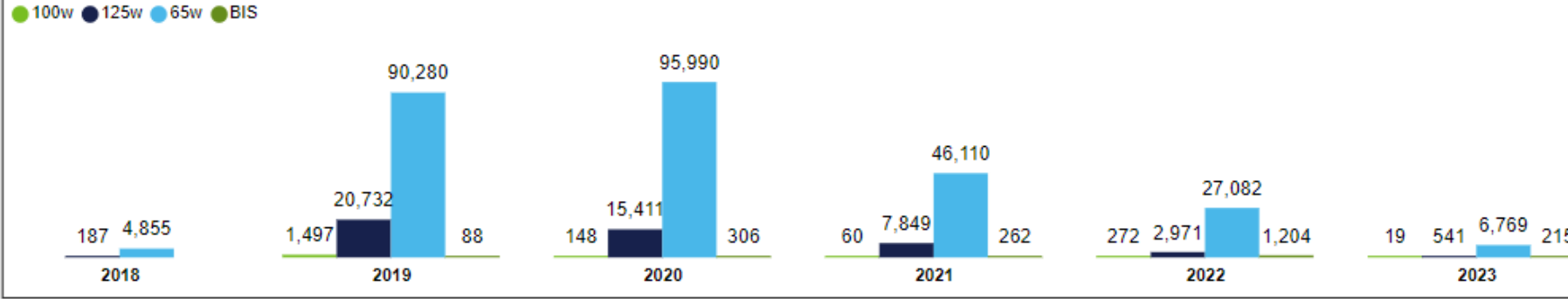

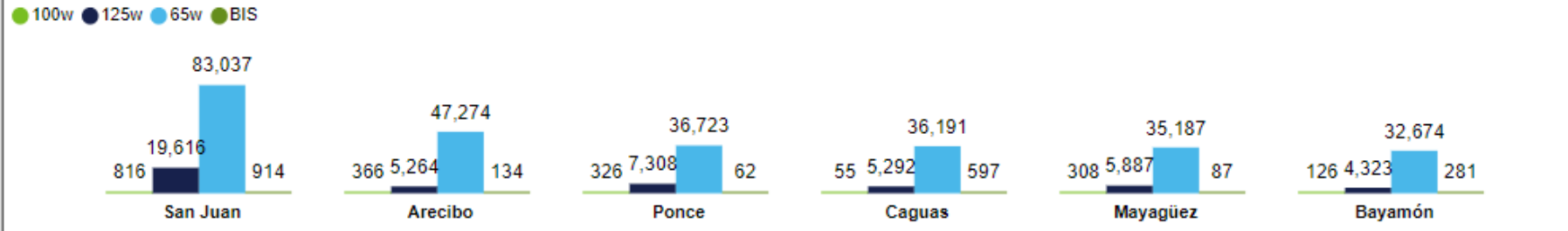

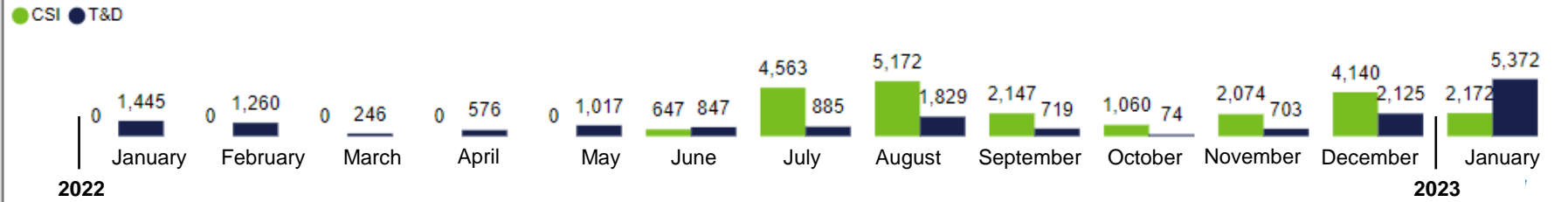
Streetlights Back in Service by Year

2022 / 2023 Monthly LED Replacement Trend

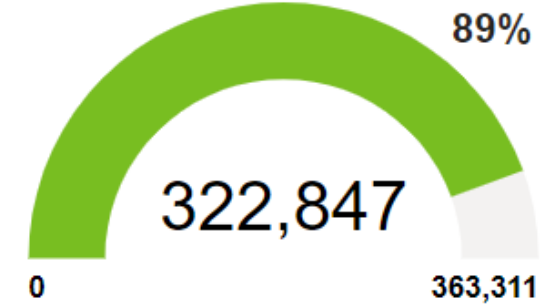
