## **RESOLUTION NUNC PRO TUNC**

On February 27, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("February 27 Resolution") through which it made its determination on LUMA's FY23 Annual Budgets and LUMA's FY24 Annual Budgets pre-filing requirements.

On page 29 titled I. FY 2024 Annual Budget Filing of the February 27 Resolution states ".... the Energy Bureau here specifically directs that the FY2024 Budget Proposal shall be submitted on or before March 15, 2023." The Energy Bureau CLARIFIES that the correct date is April 15, 2023, instead of March 15, 2023. Accordingly, the Energy Bureau CORRECTS, motu proprio, said clerical error through this Resolution. The section now reads as follows:

## I. FY 2024 Annual Budget Filing

The Energy Bureau fully expects that in view of the One Year Budget Examination procedure established for the FY 2023 Budget Examination in accordance with the 2017 Rate Order, that LUMA will submit the consolidated FY 2024 Budget proposal within the same timeframe, however, for the avoidance of doubt, the Energy Bureau here specifically directs that the FY 2024 Budget Proposal shall be submitted on or before April 15, 2023.
