RESOLUTION AND ORDER

On February 9, 2023, LUMA filed before the Energy Bureau a document titled Motion Submitting Nine FEMA Approvals of Projects, Request for Confidential Designation and Treatment and Supporting Memorandum of Law ("February 9 Motion"). As Exhibit I to the February 9 Motion, LUMA included copies of approvals by FEMA of several T&D Projects, issued on January 31, 2023, and request confidential designation and treatment.¹ LUMA alleged that FEMA approvals in Exhibit 1 contains portions of confidential information in the form of critical energy infrastructure information or critical electric infrastructure information ("CEII") that garners protection from public disclosures pursuant to federal statutes and regulations;² sensitive commercial information and trade secrets under Act 80-2011;³ and the Energy Bureau policy on management of confidential information,⁴ that therefore is also protected under Puerto Rico law.⁵ LUMA states that the confidential designation and treatment is a necessary measure to protect the specific location of the energy facilities listed or discussed in the FEMA approvals in Exhibit 1.

LUMA requests the Energy Bureau to grant confidential designation and treatment to the referred portions of Exhibit 1 as described in Table 1 below:

Act 57-2014⁶ establishes that any person having the obligation to submit information to the Energy Bureau, can request privilege or confidential treatment to any information that the party submitting understands deserves such protection.⁷ Specifically, Act 57-2014 requires the Energy Bureau to treat as confidential the submitted information provided that "the Energy Bureau, after the appropriate evaluation, believes such information should be protected".⁸ In such case, the Energy Bureau "shall grant such protection **in a manner that least affects the public interest, transparency**, and the rights of the parties involved in the administrative procedure in which the allegedly confidential document is submitted."⁹

Upon review of LUMA's arguments and the applicable law, the Energy Bureau **TAKES NOTICE** of the copies of the FEMA approvals included as Exhibit 1 of the February 9 Motion, **GRANTS** confidential designation and treatment to the portions of Exhibit 1 as described in Table 1 above, pursuant to the provisions of Article 6.15 of Act 57-2014, and **TAKE NOTICE** that LUMA has already submitted a revised redacted (*i.e.*, public) version of Exhibit 1 as described in Table 1.
