RESOLUTION

On March 29, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("March 29 Resolution") to amend the procedural calendar of the instant proceeding. Through the March 29 Resolution, the Energy Bureau made the following calendar revisions: it set April 27, 2023, as the deadline to file final substantive and legal briefs by the parties, established May 18, 2023, as the deadline for filing of replies to final briefs by the parties, and set May 25, 2023, as the deadline for filing of comments from the general public and for filing of final briefs by *amicus curiae*. The Energy Bureau also reiterated that citations concerning the Evidentiary Hearing should be made exclusively to the Microsoft Team recording.

On April 19, 2023, LUMA¹ filed before the Energy Bureau a document titled *Informative Motion on the Evidentiary Hearing Transcript and Request for Final Amendment of the Procedural Calendar* ("April 19 Motion"). Through the April 19 Motion, LUMA informed that it currently has a full set of certified transcripts of the Evidentiary Hearing and that the last transcript of the proceeding was received from the reporter on April 14, 2023.² LUMA also stated that it would revise the transcripts in order to submit them to the Energy Bureau for ease of reference in connection with the final briefs.³ LUMA indicated that it would also refer to the Microsoft Teams recording in the legal brief.⁴ According to LUMA, a certified transcript of the Evidentiary Hearing is necessary for an orderly proceeding.⁵ LUMA further stated that Counsel for the Puerto Rico Electric Power Authority ("PREPA") confirmed that it required a period of two weeks to review the transcripts.⁶

In view of the above, LUMA requested that the April 27, 2023 deadline to file final substantive and legal briefs by the parties be extended until at least May 11, 2023, to allow LUMA and PREPA to review and stipulate transcripts.⁷ LUMA also requested that the remaining deadlines in the procedural calendar be rescheduled accordingly.⁸

Upon review of the April 19 Motion, the Energy Bureau **GRANTS** LUMA's request to amend the procedural calendar and **AMENDS** the procedural calendar of the instant case as follows:


