## RESOLUTION

On May 3, 2023, the Energy Bureau of the Puerto Rico Public Regulatory Board ("Energy Bureau") issued a Resolution and Order ("May 3 Resolution") in which, among others, it amended the procedural calendar in the instant case.

On May 4, 2023, LUMA Energy, LLC and LUMA Energy ServCo, LLC (jointly referred to as, "LUMA") filed a document titled Informative Motion on Status of FY2024 Budget Allocation Discussions, Request for Additional Time to Conclude Discussions, and Petition for Modification of Procedural Calendar ("May 4 Motion"). In its May 4 Motion, LUMA stated that after discussions with Genera PR, LLC ("Genera") and the Puerto Rico Public-Private Partnerships Authority ("P3A") and as a result of the incremental work and coordination that would be needed to apply the P3A's Budget Allocation Determination and produce a consolidated budget proposal that is ripe for review by the Energy Bureau, the May 8th filing deadline originally proposed by LUMA was no longer feasible.<sup>1</sup> In light of the foregoing, LUMA requested that the Energy Bureau amend the procedural calendar to grant the parties until May 16, 2023, to meet, confer, and adopt the Consolidated FY2024 Proposed Annual Budgets.2

Upon review of the May 4 Motion, the Energy Bureau GRANTS LUMA until Monday, May 15, 2023, to file the consolidated FY2024 Proposed Annual Budgets and AMENDS the Procedural Calendar of the instant case as follows:

- (i) noncompliance with this Resolution and Order, regulations and/or applicable laws may carry the imposition of fines and administrative sanctions of up to \$25,000 per day;
- (ii) any person who intentionally violates Act 57-2014,<sup>3</sup> as amended, by omitting, disregarding, or refusing to obey, observe, and comply with any rule or decision of the Energy Bureau shall be punished by a fine of not less than five hundred dollars (\$500) nor over five thousand dollars (\$5,000) at the discretion of the Energy Bureau; and
- (iii) for any recurrence of non-compliance or violation, the established penalty shall increase to a fine of not less than ten thousand dollars (\$10,000) nor greater than twenty thousand dollars (\$20,000), at the discretion of the Energy Bureau.
