RESOLUTION AND ORDER

On February 1, 2023, the Energy Bureau of the Puerto Rico Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("February 1 Resolution") establishing the Agenda of the Evidentiary Hearing to be held in this proceeding from February 7 to February 10, 2023. The Evidentiary Hearing was held as scheduled.

On February 14, 2023, LUMA¹ filed a document titled *Motion Requesting Audio Recording of Evidentiary Hearing*. ("February 14 Request"), requesting the official audio recording of the Evidentiary Hearing to prepare a certified transcript of the proceedings. The Energy Bureau granted the request on February 22, 2023.

On May 11, 2023, LUMA filed a document titled *Informative Motion on the Evidentiary Hearing Draft Transcripts and Request to Submit the Same Under Seal* ("May 11 Request"). LUMA indicates that since the transcripts of the proceedings must be reviewed but are not yet final, they request the Energy Bureau accepts and maintains the transcripts under seal of confidentiality until final versions are ready to file for the public record. Also, LUMA requests that the Energy Bureau grant them until June 1, 2023, to work with PREPA, and the court reporters to review the final and certified versions of the transcripts of the proceedings.

Upon review of LUMA's May 11 Request, the Energy Bureau **GRANTS** its request and **ORDER** LUMA to submit the final version of the transcripts of the proceedings **no later than June 1, 2023,** and **GRANTS** LUMA request to maintain under seal the Evidentiary Hearing Draft Transcripts until the final transcript is submitted.
