SUBJECT: Resolution pertaining to *Request* for Extension of Time to Submit Final Evidentiary Hearing Transcripts, filed by LUMA Energy, LLC and LUMA Energy ServCo, LLC.

RESOLUTION

On May 16, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order though which it granted LUMA Energy, LLC and LUMA Energy ServCo, LLC (jointly referred to as "LUMA") until June 1, 2023 to submit the final version of the Evidentiary Hearing transcripts.

On June 1, 2023, LUMA filed before the Energy Bureau a document titled Request for Extension of Time to Submit Final Evidentiary Hearing Transcripts ("June 1 Motion"). Through the June 1 Motion, LUMA indicated that LUMA and the Puerto Rico Electric Power Authority ("PREPA") had reviewed the transcripts and provided the court reporters with their proposed revisions.¹ Further, LUMA expressed that currently, the court reporters are going through the process of rehearing those portions of the audio in which LUMA and PREPA raised revisions.² LUMA estimated that said process will take a couple of weeks to complete, considering the interchangeable use of English and Spanish during the Evidentiary Hearing, which ultimately requires producing two sets of transcripts and extends the labor of the court reporters.³ In light of the above, LUMA requested that the Energy Bureau grant until June 22, 2023 to submit the certified transcripts.4

Upon review of the June 1 Motion, the Energy Bureau GRANTS LUMA until Thursday, June **22, 2023** to submit the final version of the Evidentiary Hearing transcripts.
