**SUBJECT:** Urgent Request for a Brief Extension of Time to Comply with the May 23, 2023 Order

**URGENT REQUEST FOR A BRIEF EXTENSION OF TIME TO COMPLY  
WITH THE MAY 23, 2023 ORDER**

**COMES NOW** the Puerto Rico Electric Power Authority ("PREPA"), through its counsel of record, and respectfully submits and requests as follows:

1. On May 16, 2023, LUMA ENERGY, LLC and LUMA ServCo, LLC (collectively, "LUMA") filed a document titled *Submission of Consolidated Annual Budget for Fiscal Year 2024 and Annual T&D Projections through Fiscal Year 2026* ("May 16 Motion") before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau"). The May 16 Motion included the FY2024 Budget Proposal for the Puerto Rico Energy System (the "System").
2. The FY2024 Budget Proposal for the System is comprised of the proposed budget for the Transmission and Distribution System ("Proposed T&D Budgets"), developed by LUMA; the budget proposal for the legacy thermal generation units (the "Proposed GenCo Budget"), developed by Genera PR LLC ("Genera"); the budget proposal for the hydroelectric generating units and the public irrigation facilities<sup>1</sup> (the "Proposed HydroCo Budget"), and the budget proposal for PREPA and its subsidiaries other than GenCo and HydroCo (the, "Proposed HoldCo

Budget"), both developed by PREPA.<sup>2</sup>

3. On May 23, 2023, the Energy Bureau issued a Resolution and Order ("May 23 Order") which the Energy Bureau determined it needed additional information to evaluate the FY 2024 proposed budgets. Consequently, the May 23 Order included an extensive list of requests of information ("Second ROI") for LUMA, PREPA and Genera.

4. PREPA respectfully informs its officials are currently working to comply with the May 23 Order but unfortunately, the filing will not be complete by noon today. PREPA requires some additional time to review and validate the latest editions to the Second ROI draft responses. Consequently, PREPA respectfully requests this Energy Bureau, to grant a brief extension, until the end of the day (12:00 am) to submit the corresponding responses to the Second ROI.

5. PREPA certifies this brief extension of time until the end of natural day, is made in good faith, with no intention of delaying the FY2024 Budget Proposal evaluation by this Honorable Energy Bureau.

**WHEREFORE**, PREPA respectfully requests the Energy Bureau to **GRANT** PREPA until June 6, 2023, close of natural day to submit the responses to the Second ROI in compliance with the May 23 Order.
