**AMENDED REQUEST FOR EXTENSION OF TIME TO SUBMIT RESPONSE IN

TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW GENERA PR, LLC ("Genera PR"), through its counsel of record, and respectfully state and request the following:

1. On June 7, 2023, Genera PR respectfully filed an *Urgent Request for Extension of Time to Submit Response In Compliance with Resolution and Order of May 31, 2023*. In this submission, Genera PR, due to an oversight, requested an extension of time until the close of the natural day on June 7, 2023, inadvertently specifying the time limit as 12:00 AM.
