RESOLUTION AND ORDER

On April 11, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("April 11 Resolution") through which it established a procedural calendar for the instant case. The Energy Bureau scheduled a Virtual Technical Conference to be held on June 9, 2023.

On April 28, 2023, LUMA Energy, LLC as ManagementCo, and LUMA Energy ServCo, LLC as ServCo (jointly referred as, "LUMA") filed with the Energy Bureau, a document titled *Urgent Request for Additional Extension of Time to Submit Consolidated FY2024 Proposed Annual Budgets and for Modification of Procedural Calendar* (April 28 Motion), in which LUMA requested that the Energy Bureau amend the Procedural Calendar published by the Energy Bureau in its April 11 Resolution.

On May 3, 2023, the Energy Bureau issued a Resolution and Order ("May 3 Resolution") through which it granted LUMA's April 28 Motion in part and modified the Procedural Calendar, maintaining the Virtual Technical Conference scheduled for June 9, 2023.

On May 26, 2023, LUMA filed with the Energy Bureau, a document titled, *Motion Submitting Presentation for Virtual Technical Conference in Compliance with Resolution and order Dated May 3, 2023* ("May 26 Motion"), through which LUMA submitted the presentation to be offered during the Virtual Technical Conference scheduled for June 9, 2023.

On June 6, 2023, LUMA filed a document titled *Motion Requesting Agenda for Virtual Technical Conference Scheduled for June 9, 2023* ("June 6 Motion"), in which LUMA request that the Energy Bureau provide, in the form of an *Agenda*, the matters to be discussed which shall guide the Technical Conference.²

During the Virtual Technical Conference, LUMA, Genera PR, LLC ("GENERA"), and the Puerto Rico Electric Power Authority ("PREPA") shall present and discuss thoroughly the proposed FY 2024 Annual Budgets. Due to the technical nature of the Technical Conference, it will be conducted in the English Language,³ with simultaneous translation to the Spanish language.⁴

The Energy Bureau, as it has done in other proceedings, has organized, and structured the issues to be discussed during the Technical Conference by subject matter. This approach allows for a more useful dialogue, a more organized record, provides for better time management and allows a more detailed and efficient discussion. The agenda included as Attachment A of this Resolution and Order shall govern the organization of the Technical Conference.

The Energy Bureau **ORDERS** LUMA, GENERA, and PREPA to ensure that all persons (i.e., employees, consultants, or representatives) involved to prepare the FY 2024 Annual Budgets proposal appear during the Virtual Technical Conference in accordance with the foregoing
