
RESOLUTION AND ORDER

On May 23, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued an Order to Show Cause ("May 23 Order") in which it ordered Hewlett Packard Puerto Rico B.V. LLC ("HP Puerto Rico"), within five (5) days from its notification date, to (i) file its financial statements for the fiscal year ended on October 31,2022 compiled by an authorized CPA pursuant to Section 4.02(E) of Regulation 87011; (ii) show cause why the Energy Bureau should not impose an administrative fine of five hundred (\$500) for its failure to comply with Act 57-2014² and Regulation 8701.

On May 30, 2023, HP Puerto Rico filed a letter with subject "NEPR-CT-2021-0004- Response to Order to Show Cause and Extension Request" ("May 30 Letter"). Through this May 30 Letter, HP Puerto Rico informs that, as of the date hereof, the 2022 Financial Statements have not been completed, because of the complexity of the financial auditing process. HP Puerto Rico alleges it can be in a position to file its financial statements after June 30, 2023, and expects to comply with Section 4.02 of Regulation 8701 as soon as the 2022 Financial Statements are completed. In the May 30 Letter, HP Puerto Rico justifies its non-compliance due to the very complex financial process as a public traded company and request the Energy Bureau waive the imposed administrative fine of five hundred (\$500) dollars.



The Energy Bureau **GRANTS** the Time Extension requested by HP Puerto Rico. The Energy Bureau **ORDERS** HP Puerto Rico to file, **on or before** June 30, 2023, its Financial Statements for the Fiscal Year ended on October 31, 2022 compiled by an authorized CPA pursuant to Section 4.02 (E) of Regulation 8701, as amended.



The Energy Bureau **REMITS** the administrative fine of five hundred dollars (\$500) imposed to HP Puerto Rico.

The Energy Bureau WARNS HP Puerto Rico that non-compliance with Energy Bureau's orders and regulations may carry the imposition additional administrative fines.
