
**RESOLUTION**

On April 17, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board (“Energy Bureau”) issued a Resolution and Order (“April 17 Order”) in which it order ROOFTOP SOLAR JV, LLC (“ROOFTOP”) to within fifteen (15) days, from the notification date, (i) correct its Gross Revenue and Financial Statement Report to present its Gross Revenue for the Natural Year 2022 pursuant to Section 4.02 of Regulation 8701<sup>1</sup>, as amended; (ii) file such report before the Energy Bureau.


