SUBJECT: Motion to Submit Status Reports and Request for Confidential Designation

and Treatment.

RESOLUTION

On June 16, 2023, the Puerto Rico Electric Power Authority ("PREPA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion to Submit Bi-Monthly Status Reports dated June 15, 2023 on the Emergency Generation and Black Start Generation Procurement in Compliance with the January 23 Order ("June 16 Motion").* As part of its filing, PREPA requested confidential designation and treatment of the documents attached to the June 16 Motion, Annexes A and B.

PREPA alleges that the information disclosed in Annexes A and B includes information on evaluating proposals and the process is ongoing. Annex A is document titled *RFP 3784, Power Advocate Event 138790 New Black Start Units Yabucoa and Costa Sur Power Stations* which is Status Report on the black start generation procurement process. As Annex B, PREPA includes a document titled *RFP 3800, Power Advocate Event 139303 New Peaker Units for the Daguao, Jobos, and Palo Seco Power Stations,* which is a Status Report on the emergency generation procurement process.

Act 57-2014¹ establishes that any person having the obligation to submit information to the Energy Bureau, can request privilege or confidential treatment to any information that the party submitting understands deserves this protection.² Specifically, Act 57-2014 requires the Energy Bureau to treat as confidential the information submitted provided that "the Energy Bureau, after the appropriate evaluation, believes such information should be protected".³ In such case, the Energy Bureau "shall grant such protection in a manner that least affects the public interest, transparency, and the rights of the parties involved in the administrative procedure in which the allegedly confidential document is submitted."⁴

Upon review of PREPA's arguments and the applicable law, the Energy Bureau **GRANTS** confidential designation and treatment to Annexes A and B submitted, pursuant to Article 6.15 of Act 57-2014.
