## **NUNC PRO TUNC RESOLUTION**

On July 11, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued an Order in the instant proceeding notified on July 11, 2023.

In the fourth paragraph of the issued Order, due to an error, it was included that Genera had to comply with the order **on or before July 14, 2023 at 12:00 a.m.**, when it should have indicated 12:00 p.m.

The Energy Bureau **TAKE NOTICE** of the Genera July 9 draft and **ORDERS** GENERA to submit, **on or before Friday July 14, 2023, at 12:00 p.m.**, the memorandum of law explaining the legal basis and support for a request to file information confidentially and the table identifying the confidential information, a summary of the legal basis for the confidential designation, why each claim or designation conforms to the applicable legal basis for confidentiality, and to submit a revised redacted (*i.e.*, public) version of the Fuel Optimization Plan, in accordance with this Resolution and Order.
