TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority (PREPA) through the undersigned legal representation and respectfully submits and requests as follows:

1. On July 14, 2023, PREPA filed a motion titled *PREPA's Response To Motion Requesting Order To Affirm Genera PR's Exclusive Responsibility In Managing And Decision-Making For Ongoing Public Procurement Processes And Facilitation Of Related Documentation Transfer*.
2. In the motion, PREPA agreed that Genera complete the RFPs 3784 and 3800 process. However, PREPA wants to supplement its response with a document titled *Executive Summary RFP 3784 and RFP 3800*.
3. This document includes confidential information regarding RFPs 3784 and 3800. As such, PREPA respectfully requests that the Energy Bureau treat it as a confidential document pursuant to Article 6.15 of the Puerto Rico Energy Transformation and Relief Act, Act no. 57 of May 27, 2014, and Section V, ¶ 13 of the Regulation for the Program to Administer Documents of the Puerto Rico Electric Power Authority, No. 6285.
