RESOLUTION

On June 21, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("June 21 Order") in which it ordered GASNA 18P, LLC. ("GASNA") to, within five (5) days, from the notification date, (i) pay the five hundred dollars (\$500) administrative fine with the Energy Bureau's Clerk; (ii) update its Personal Information (Form NEPR-B01) if needed; and (iii) file its compiled Financial Statements for the year ended December 31, 2022, compiled by a CPA authorized to practice such profession in Puerto Rio, or in any jurisdiction of the United State of America.

On June 30, 2023, GASNA filed before the Energy Bureau a document titled *Motion in Compliance with Order and Request for Extension of Time* ("June 30 Motion"), including the following documents (i) *Updated Personal Information Electric Power Companies Form* - Form NEPR-B01 ("Updated Personal Information Form"), and (ii) *Complementary Sheet* – Form NEPR-Z01, (collectively "Attachments").

In the June 30 Motion, GASNA states that (i) it requires an extension until July 6, 2023, to submit the payment of the administrative fine and the filling fee for Form NEPR-B01; and (ii) requests PREB to grant an additional term of twelve (12) days, until July 12, 2023, to file the compiled financial statements.

GASNA updated Parts A, B, C, D, E, F and G of its Personal Information Form (Form NEPR-B01).
