RESOLUTION AND ORDER

On April 10, 2023, LUMA Energy, LLC and LUMA Energy ServCo, LLC (collectively, "LUMA"), filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled Motion Submitting Report on Streetlight Repairs for March 2023 and Request for Modification of Reporting Frequency ("April 10 Request"). Motion LUMA proposes changes in the schedule for submitting the Streetlights Repairs Reports, from monthly to quarterly, so it is more closely aligned with the frequency for reconciliation and calculation of the factor for the SUBA-HH rider and other progress reports that LUMA must provide in other dockets and to provide for more efficient reporting.¹

LUMA requests the Energy Bureau to take notice of the aforementioned, consider LUMA in compliance with the Energy Bureau order regarding the submittal of the monthly streetlight repair reports for March 2023, and approve the changes to change the frequency of the streetlight repairs reporting from monthly to quarterly.2

On August 18, 2023, LUMA, filed a document titled Motion Reiterating Request to Modify the Cadence of the Report on Streetlight Repairs ("August 18 Motion"). Through the August 18 Motion, LUMA requests the Energy Bureau to change the frequency of the Streetlights Repair Report. LUMA reiterates that changes in the schedule for submitting the report from monthly to quarterly, will allow to be more closely aligned with the frequency for reconciliation and calculation of the factor for the SUBA-HH rider and other progress reports that LUMA must provide in other dockets, and it will result in more efficient reporting.³

After a review of LUMA's request, the Energy Bureau takes notice and GRANTS LUMA's April 10 Request and the August 18 Motion. The streetlights repair reporting frequency is changed from monthly to quarterly.
