**MOTION REQUESTING EXTENSION OF TIME TO FILE AMICUS BRIEF**

COMES now, COLEGIO DE INGENIEROS DE PUERTO RICO ("CIAPR"), through the undersigned attorney, and respectfully states and requests the following:

1. As per the Order and Resolution dated May 23, 2022, the date to file the Amicus Final Briefs was due 7 days after the Filing of Replies to Final Briefs by the Parties.
2. As per the Order and Resolution dated August 17, 2023, the date to file the final Reply Briefs was extended to September 7, 2023.
3. As per Order and Resolution dated the First of September, 2023, this Honorable Agency authorized an extension of time to LUMA Energy LLC and Luma Energy ServCo. LLC to submit its final brief to September 21, 2023.
4. The Orders and Resolutions dated August 17, 2022 and September 1<sup>st</sup>, 2022, do not specify the date for filing of the Amicus Final Briefs.
