## **RESOLUTION AND ORDER**

On July 31, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order through which it established the quarterly factors for the FCA,1 PPCA,2 and FOS3 Riders, to go into effect until September 30, 2023. Further, the Energy Bureau ordered LUMA Energy, LLC and LUMA Energy ServCo, LLC (referred to jointly as "LUMA") to submit, on or before September 15, 2023, at noon, the proposed FCA, PPCA, and FOS Riders to be implemented from October 1, 2023 to December 31, 2023, including the proposed reconciliations for July and August 2023.

On September 18, 2023, the Energy Bureau granted LUMA until Wednesday, September 20, 2023 to submit the quarterly reconciliations and proposed factors to be implemented on October 1, 2023. The Energy Bureau **REMINDS** LUMA to include in its proposed factors the impact of the 350MW of temporary generation at Palo Seco and San Juan, which fuel costs shall be paid with FEMA funds. The Energy Bureau further ORDERS LUMA to include with its filing the calculation of the forecasted savings and cost per kWh savings such temporary generation would represent to the people of Puerto Rico during the next trimester.
