SUBJECT: Nunc Pro Tunc Resolution

NUNC PRO TUNC RESOLUTION

On September 22, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order in the instant proceeding ("Resolution").

In the 4th paragraph of page 10 of the Resolution, the Energy Bureau referenced certain information with footnote 41, due to an error, **Footnote 41** indicated *Id.* This footnote should have stated:


