SUBJECT: PREPA extension request for the filing of the totality of the FY24 contracts.

RESOLUTION AND ORDER

On June 25, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("June 25 Resolution") through which it modified the Proposed Consolidated Fiscal Year 2024 ("FY24") Budget submitted by LUMA Energy, LLC and LUMA Energy ServCo, LLC (collectively referred to as, "LUMA") and approved the modified budgets subject to compliance with various orders in the June 25 Resolution. The Energy Bureau further ordered the Puerto Rico Electric Power Authority ("PREPA") to file for review and approval, any new contract or amendment to an existing contract, before executing or making any award of such contract or amendment.

On October 3, 2023, PREPA filed a document titled PREPA's Request for Extension of Time to Comply with the September 27 Order ("October 3 Motion"). Through the October 3 Motion, PREPA request an extension of twenty (20) business of days to the deadline established in the Resolution and Order issued September 27, 2023 ("September 27 Order") requiring PREPA to file the totality of the contracts PREPA plans to execute for FY24.1 In the October 3 Motion, PREPA alleges that they have gathered the contracts and are in the process of discussing with the heads of PREPA departments the contracts to be submitted in conformity with the FY24 Approved Budget.²

Upon review, the Energy Bureau GRANTS PREPA ten (10) business days to file the totality of the contracts PREPA plans to execute in FY24 under the NOTICE that the Energy Bureau shall not address any PREPA contract approval requests submitted after the issuance of this Resolution and Order until PREPA complies with such order. Therefore, the Energy Bureau extends the deadline to October 19, 2023. If PREPA fails to comply with the Energy Bureau's Order, by this new deadline, the fine will be set accordingly, as stated in the September 27 Order.
